

Officials Chair Report
Prepared for the IASI Board of Directors Meeting
October 5, 2026

Officials Numbers:

At the start of the 2025-2026 Short Course Season, effective on October 1, 2025 USA Swimming's Officials Tracking System (OTS) indicates that we currently have 214 Apprentice and Certified Officials. Of those 184 are eligible and certified to officiate at Meets. The differential includes 16 apprentice officials who are yet to be fully certified and the remaining balance are registered officials who have expired Background Checks or Athlete Protection Training.

As for the various positions the following is a summary of the official numbers for various positions:

Iowa Swimming has 69 Officials (38%) who have achieved at least one N2 or N3 National Certification. That percentage places Iowa Swimming as one of the top LSCs for nationally certified officials in all of USA Swimming.

Background Check Reimbursement

Effective September 1, 2025, Iowa Swimming will reimburse certified officials for their background check expense. Once the official completes their background check, the official will need to complete a form and submit the form with a receipt for the background check payment. Upon verification that the background check has been completed, Iowa Swimming will send a reimbursement check. Those officials whose BGC expired in September or will expire in October were emailed the form and directions. The goal is to get the form to officials a month before their BGC expiration date. The process is new and may evolve, but it is our goal to make this relatively simple.

Officials Shirts

Also included in this year's budget was a line item to provide all current and new officials with one Iowa Swimming Officials Shirt. Details on how this will be achieved are still in development and more information will be forthcoming.

Officials Qualifying Meets

We will again be trying to offer multiple OQM opportunities for officials to be evaluated for national certification. The first OQM Meet this season will be at the Midwest Challenge on October 31st through November 2nd. The meet will offer N2 and N3 evaluations for all positions. The sign up is currently available on the Iowa Swimming Officials Meet Sign Up page. We plan to have national evaluators at both the Short Course and Long Course Championships in 2026. The tentative National Evaluators will be Jim Sheehan, who is a past USA Swimming President of Board of Directors, at the Short Course Senior Championships; and Lisa Vetterlein, who was one of the Starters at the Paris Olympics, at the Long Course Championships next summer.

Recertification & Membership Registration

It is that time of the year again when Officials need update your membership with USA Swimming for the 2026 calendar year. We will also need to check their LSC Certification status in OTS. Any positions showing an expiration date of 12/31/2025 will need to complete one or two clinics through USA Swimming University to recertify. For those who have certifications expiring, the Officials Committee will be checking to ensure that official has officiated at the minimum number of sessions as established by USA Swimming. Of they are short sessions, there still are opportunities to meet the minimum number of sessions before the end of the year.
