 - Proposal to amend Iowa Swimming Inc. Policies & Procedures, Section I VII.H as follows:
 - H. Meet Marshals. Meet Marshals do not need to be non-athlete members of USA Swimming for IASI sanctioned meets. Meet Marshals report to the meet's referee and have authority through the meet's referee to maintain general safety and order throughout the venue. Meet Marshals have full authority to warn or order to cease and desist, and to remove, or have removed from the competition venue anyone behaving in an unsafe manner or using profane or abusive language, or whose actions are disrupting the orderly conduct of the meet. Meet Marshals are to be clearly identified at all times. For example, while on duty, meet marshals shall wear an orange vest. (reserved for future use)

Rationale:

New guidance from USA Swimming will require all Meet Marshalls to be members of USA Swimming, and comply with Athlete Protection Training and Background Check beginning January 1, 2022. In the current condition, IASI Policy & Procedures would be in conflict with USA Swimming. Additionally, USA Swimming Rule 102.10.3 and 102.10.4 specify that while Marshal(s) are required, the number is determined by the LSC. This change keeps IASI P&P compliant with USA Swimming and reserves a place for our LSC to specify the number of Marshal(s) required in the future, after consideration by the Official's committee.

 Proposal to rescind Board Action of April 28th 2020 regarding fines assessed for change of Bid Meets: Section I.I.E.2.

<u>Rationale:</u> Allows IASI to impose fines to clubs via process laid out in Section I.1.E for changes to meets on the IASI Calendar. The action was put in place to alleviate clubs of cancellation fines due to COVID shutdown. At this time, the action taken by the board April 2020 restricts any imposition of fines for any reason to cancellation, change or addition of meets. Acceptance of this proposal reinstates the mechanism still in place Notification and Exemption of Fines laid out. This proposal empowers the Senior Vice Chair and Admin Vice Chair to review and assess fines if warranted, upon acceptance of Board.

 <u>Rationale</u>: IASI Bid and HOD meetings pre-COVID were held in person. The Benefits of in person face to face meetings have been cited throughout the business community. <u>This article summarizes best</u>. The success of any business is only as good as the relationships between Executives, Employees and Customers. This may be applied to IASI as our Board and Committees, Staff, Members.
 - 2. Adjust the Approved Budget to include in person meetings to \$400 and Employee expenses for travel.
 - 3. Change the Spring House of Delegate Meeting Date from April 24th to May 1st.

 <u>Rational:</u> April 24th conflicts with the USA Swimming Workshops. These workshops replace the USA Swimming Convention typically held in the fall.
