Finance Chair Report - December 7, 2025

Below is a report that shows each revenue/expense line in the IASI budget along with the sum of revenues/expenses that have been accounted for as of October 31, 2025 for this fiscal year.

The LSC has collected 15% or its budgeted revenues. This is slightly ahead of last year when 14% of actual revenues were collected by the end of October.

The LSC's total expenditures are 9% of the budgeted amounts. This equals the percentage of total expenditures used at the same time with last year's actual expenses.

Please note that this year, the LSC budgeted a fiscal loss of \$51,732.

The budget lines of concern through October are the following:

- Postage Already used 612% of this budget line. An excess of \$383.80. However, this expense is relatively small, \$458.60, when looking at IASI's full fiscal year.
- Newsletter Already used 148% of the annual year's budget. An excess of \$183. Again this is a relatively small expense line when looking at IASI's full fiscal year.
- National Convention Travel Already used over used this year's budgeted amount at 113% of the budgeted amount. Spent \$10,720.08. Budgeted \$9,500. An excess of \$1,220.08.
- Current IASI Financial Policies and Procedures were not followed when approving these excess expenditures.

Here is the summary of the Finance Committee Meeting held on November 23, 2025.

Bobby Kelley and Kenny Nedder, the only participants, initiated the work for the new fiscal year by confirming Kenny Nedder's appointment as Vice Chair. They reviewed current financial reports, noting significant budget overages in postage and the conventions and workshop lines. Bobby proposed a "financial review" task force involving Kenny Nedder and Ryan Judas to review the financials with Doug Kolsrud. They also discussed the need to review IASI Financial Policies and Procedures document, review the first draft of the Finance Committee's Policies and Procedures, and proposed seeking board authorization for the finance committee to sell sponsorships and contract with vendors, including the Team Iowa vendor. This item is proposed in New Business.

Future Finance Committee meetings will be at 7:00 PM on the third Sunday of every odd month. The next Finance Committee meeting will be on Sunday, January 18, 2026.
