OJ spoke of the telephone conversations between himself and USA Swimming's Leland Brown and DEI issues. USA Swimming advised us to look at the Louisiana State laws regarding some of the issues that we are seeing. Louisiana swimming has procured a lawyer and are now working with him on getting a retainer with his firm. Please know that at this point the particulars in this situation should be kept within the board further conversations outside the board are not allowed. Just know that if a transgender is coming to your Meet the transgender's coach must contact the Meet Director and the Meet Referee. These individuals should contact Sarah, OJ and Lomax to ensure all procedures are being followed. Questions came up whether this information will come out on Meet information. OJ will be looking into this and get back to everyone. Facility, rules and procedures should be looked at by all individuals to see if there are any rules that are stricter than what USA Swimming or Louisiana state laws may have.
