#### CALENDAR PROTECTION MOTION #1

*Technical Committee recommends that this motion be considered.* 

Background: The Technical Committee seeks to adjust the Calendar Protection policies and procedures based on feedback from coaches and athletes so that the policy reflects the best interests of New England athletes.

Change the following sections of the New England Swimming Rules and Regulations for Competition: II. SWIM MEET POLICIES AND PROCEDURES

## F. Calendar Protection

New England Swimming will continue to protect the dates of the New England Swimming Annual Meeting, or other House of Delegate meetings, the New England Swimming Award Banquet, and the "end of season" meets: New England Age Group Qualifier Meets, New England Regional Meets, New England Silver Meets, New England Age Group Championships, New England Open Championships and the New England Senior Championships.

Meets will be sanctioned or approved on these dates only according to the following protocol:

- 1. No meets will be sanctioned, approved or observed at the same time and date of the New England Swimming Annual Meeting or other HOD Meeting.
- 2. No meets will be sanctioned, approved or observed at the same time and date of the New England Swimming Award Banquet.
- 3. Only meets for New England Senior qualifiers and above will be sanctioned, approved or observed on the same dates as the New England Age Group Qualifier Meets, the New England Regional Meets, the New England Silver Meets, the New England 12 and Under Championship Meet and the New England 14 and Under Championship Meet
- 4. Only meets for 12 and younger athletes will be sanctioned, approved or observed on the same dates as the New England 15-18 Championship Meet and the New England Senior Meet.
- 5. Any swimming competition affiliated with the National Congress of State Games may be approved on any date at no fee to the organization, with observation forms collected (\$5.00 each splash).
- 6. High School conference, Sectional and State Championship meets may be observed on any date.
- 7. NCAA Collegiate meets may be observed on any date.

This policy will be printed on the meet bid form.

This policy will take effect on September 1, 2015. Motion passes 11:1

- 1. Discussion regarding empty lanes at Senior Meets 72 DFS at this meet. This is a big issue in events 400 & over. Suggestion is to do positive check in the morning of the event for these as long as the event is at the end of the prelim session.
- 2. Discussion regarding late entries to the meet more severe penalty?
- 3. December Senior Meet
  - a. discussed SCY vs SCM decided to keep SCY.
  - b. Senior Meet Awards something more representative of the achievement of winning a Senior meet event. Committee athletes will be working on this.
  - c. Awards will be done same as this summer meet
  - d. Swim 10 lanes at night.
  - e. College recruiting session between sessions on Saturday.

- f. Wake-up swim and Thursday night swims
- 4. March Senior Meet first weekend
  - a. Considering a sprint style Senior meet format TBD if there is interest.
- 5. July LCM Senior Meet
  - a. Suggestions change prelim warm-up to 1.5 hours and allow three 10 minute breaks and have three lanes open during awards at finals for 5 minutes.
  - b. C final 18 & under
  - c. Out of LSC teams not enough room but discussion after meeting about including Maine as we share services with them and they have no long course pools available. Would only be about 25 kids or less.
  - d. Official's National Certification Meet
  - e. Timing of B final since sessions are short, teams should stay and time the B finals in their timing assignment, especially since SSA/SEEK covered all of the evening assignments.
- 6. 2016. Thoughts on moving Senior meet earlier vs. perhaps working with a club hosting a meet to create a fast meet in June that would be a National Qualifying Meet with teams from outside the LSC to provide as many opportunities to make trial cuts as possible.

Safe Sport presentation/talking points New England Swimming Board Meeting July 21, 2015

#### Safe Sport/ Risk Management

**Changing culture:** 

Culture and our own comfort zones govern the way each of us operates in our respective worlds. And change is hard. It's hard to hand over power to a national governing body, or faceless office. At the LSC level, the job of the Safe Sport committee is to communicate good sense risk management, even if it involves change.

Our job is to connect you with resources, provide support, and connect you with others who can advise or stand by you when appropriate. There is so much material available on the Safe Sport section of the USA Swimming website that it may seem daunting, but if you make a timeline for yourself and your club, you can learn from all of it. For example ....

Are you thinking about hiring for short course? Well, then, now is the time to read the materials about background checks, interview scripts, and calling references. You might learn something new. For example, is it your practice to do a social media search or Google the job candidate? If so, name one potentially problematic issue that might arise from that practice: \_\_[primarily looking for anything you can't ask in a job interview] . How do you handle the unintended consequences of gathering information about your potential hires?

We recommend that you hold parent meetings at the beginning of the season, even if it isn't your usual practice. Ask us to help you devise some scenarios to use for talking points or role plays followed by discussion. Fill out the form that Carol will shortly make available so we can plan how best to help you. Consider having parents watch the parent training video IN THE MEETING. Ask us to provide materials on Safe Sport and risk management to include in your team handouts.

Thinking a little more long-term ....does your team website truly serve your needs? Are you comfortable with the photos thereon being in the public domain, legit for any news organization to use in a report? Are your club policies up to date? If a parent on your club has a Safe Sport concern, will they be able to easily find your club policies and contact information for help? Do you have a tab for Safe Sport links? Look objectively at the access, privacy, and control of each adult associated with your club. If something looks sketchy to you, don't dismiss it.

Do your swimmers expect a hug after a great swim? Try elbow taps or high fives instead, and tell them why. How about a large swimmer delightedly celebrating a great swim or dive, and picking up a tiny coach?

What do you do when you need to take a swimmer aside for a private conversation? Make sure your office door is

open or that you and the swimmer are visible to others. In this context, private is not private.

Do your swimmers sit on each other's laps at a meet or in a van? Might one of your coaches come along and join a tower of kids sitting on one another? Just say no. Enlist all of your coaches in this effort, so the athletes get consistent messages from everyone.

Did you know:

USA Swimming has a handout called "RECOMMENDED PRACTICES FOR THE INCLUSION OF MINOR TRANSGENDER ATHLETES"?

USA Swimming provides powerpoints and handouts to help you run Safe Sport meetings with your coaches, athletes, and parents?

#### **Scenarios:**

A swimmer comes to you and says that one of the assistant coaches plays favorites. In the course of your conversation with her, it turns out that her friend, also a swimmer on your team, and the assistant coach have been texting regularly. What is your next step?

Your swimmer comes to you at the end of a meet session, crying, and says that her ride left without her and she has no way to get home.

You're at an end-of-season meet and observe an adult on deck whom you know is without the proper credentials. To whom should you speak?

Rules and boundaries need to be consistent for coaches, athletes, and parents. We can't have the perception that there's one set of rules for people with "connections" and one set for everyone else. Have a question? Call or email me. If I don't know the answer I will find someone who does. Don't worry alone —and don't ever say to yourself "oh, it's nothing."
