1. Welcome and Introduction, Laura Matuszak

- a. Moment of silence for Fran Crippenb. Introduction of the Athlete Representatives
- c. Review of last month's survey 7 responses indicated very productive
- d. LSC Strategic Planning Update funds to Inclusion Committee for National Heritage Meet we did fund some non-USA registered athletes. That was a decision to support minority swimmers. Discussion as to whether or not to include only USA Registered swimmers next year. Should be discussed at the January meeting – done as separate line item out of budget as not voted on last year.
- Consent Agenda, Laura Matuszak: Secretary's report pulled for typographical corrections. Motion made by Priscilla Davis and seconded by Joe Frazier to accept minutes with corrections. Motion passes.
- Treasurer's Report, Joe Frazier: Increase in registrations and surcharges. Budget was done before Mary Riddell's retirement so office expenses have increased with new Office Manager position, but postage and website down expenses have been reduced. Increase in expenses from Zones due to increase number of swimmers from 85 to 120. Overall, ahead of budget. Budget will be approved in May. What do we need for funding to institute projects to reach our goals? Question about Board designated fund – it is in the CDs. Monthly report deferred.
- Reimbursement requests, Carol Healey: Discussion of reimbursement. Motion made by Mariella Allard to approve reimbursement to Blake Zeiger (ABF). Seconded by Bob Menck. Motion passes.

Reimbursement policy 2010-2011, Mariella Allard:

- Mariella discussed what other LSCs do in relation to college swimmers and how long they must be registered with an LSC to receive reimbursement. We are the first LSC to bring up the idea of community service instead of swimming to meet a participation requirement. Swimmers would have to submit a proposal for community service thirty days before start of season to be approve by board before long course season begins.
- b. Definition of "Full participation". Kathy Dacey noted that the original purpose is to bring back our top athletes to compete with our grass roots athletes. Kathy recommends we put mission statement on this to know why we are doing this. Chuck Batchelor would like to see kids swim what their coach wants and then stay at the meet if they are not participating any further. Jamie Bloom gave example of Elizabeth Beisel at an ABF meet on deck. She hung out with the kids, autographs, good example. This is what we want from our athletes.
- c. Motion made by Ray Grant to accept reimbursement policy, seconded by Bob Menck. Discussion: Typographical changes, Ray moved to make an amendment to change 2 year requirement to one year in case a swimmer moves in just prior to senior year or joined swimming late in high school. Seconded by Bob Menck. Ray also makes an amendment that the receipt contains the name of the athlete. Seconded by Joe Frazier. Chuck makes an amendment that states there will be no waivers to this policy. Vote 1: amendment passes. #2 Request seconded by Joe Frazier. Motion passes.
- d. Who will follow-up that community service is actually done? On reimbursement form they will have to note what they did. Carol Healey will make form for proposal of Community Service. Mariella Allard calls to vote, seconded by Bob Menck. Motion passes.
- 6. Calendar, Ray Grant: Long course Jack Fabian to get date for Open Water Championships and will go out to bid. Carol Healey reminds everyone that order of championships switched.
- 7. Technical Committee Report, Mariella Allard: Zone Coach stipend. Motion made by Mariella Allard, Seconded by Joe Frazier. Motion
- Swimposium and Banquet, Jamie Bloom and Carol Healey: Jamie said feedback overwhelming. Cullen Jones amazing. 40 11 and unders, 48 - 12 & overs. 14 kids in morning and 17 kids in afternoon that were on stipend. 602 at banquet. CLBMS - JJ Sabatino said it was great. Should do something with coaches every year. Jamie reminded that we need to put out an evaluation form next time. Rick Osterberg did a wonderful job with the certificates this year.
