MEET FORMAT: The meet will be swum as timed finals. Each session will be seeded by computer based on positive check-in at the beginning of the warm-up. Coaches will receive a positive check-in sheet before each session that must be returned no later than 30 minutes before the beginning of each session. Heat sheets will be posted around the pool deck. Coaches will be able to pick up heat sheets for each session at the control desk. No events will swim with more than one swimmer per lane.

MEET WEB SITE: All meet information will be posted on the New England Y Regional Web Site, www.teamunify.com/ymcane. All Meet Information will be listed under the "2020 YMCA Eastern Mass Districts" tab or on the home page.

SITE: The WPI Pool is located on the campus of Worcester Polytechnic Institute. The competition pool is a 10-lane, 25-yard pool with seven-foot-wide lanes and non-turbulent lane lines. The timing system includes a fully-automatic Colorado Time Systems electronic timing system with touchpads at the finish and turn ends of the pool with an LCD Scoreboard display. The diving well is separated from the competition pool by a movable bulkhead and there will be four (25 yard) lanes available for warm up and warm down. The finish end of the pool is 6'5 to 8 feet deep; the turn end of the pool is 6'5 to 8 feet deep. Spectator seating is for 350, with overflow seating looking over the width of the pool for another 400 people. The pool is located inside the WPI University Athletic Complex, GPS Coordinates for the parking garage (when available) are 162 Salisbury Street, Worcester, MA 01602. Please enter through the mezzanine entrance located off the drop off circle. Directions may be found later in this document. The competition course has been certified in accordance with 104.2.2C (4). The copy of such certification is on file with USA Swimming.

COURSE: Short course 25 yards.

WEATHER PROTOCOL: If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have the right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is a decision of the Meet Director and the Meet Referee.

ELIGIBILITY: All swimmers must be current members of their YMCA and they must have had an active membership for 90 days prior to the championships. Swimmers must meet the eligibility rules as outlined in the National YMCA rules that govern competition. YMCA CEO must certify eligibility of all swimmers entered. USA Swimming members, in good standing, will have their times entered into the national SWIMS database.

Age is determined by the age of the swimmer on the first day of the meet. Any swimmer entered in the meet must be certified as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

SWIMWEAR: Per New England Swimming policy, swimmers age 12 years old and younger are not allowed to wear "Tech" suits at any sanctioned or approved meet. The age of the swimmer is determined on the first day of the meet. A list of banned suits is found on www.neswim.com under ADMIN/Governance/Policies.

SWIMMERS AGE: Effective October 1, 2019, a swimmers age the first day of the meet is their age for the meet they are participating in. This is in compliance with Y-USA Swimming and Diving rules.

DECK ACCESS: Access to the deck is limited to swimmers competing in the current session, YMCA registered coaches, certified officials with credentials and timing volunteers assigned by their team.

DISABILITY SWIMMERS: Any current athlete members of USA Swimming with a disability, as defined by USA Swimming Rules and Regulations, may enter this meet. If modifications to USA Swimming rules are necessary the coach or athlete must notify the Meet Referee and Meet Director of any disability prior to competition.

Payment due date for all entries: January 21, 2020. Any team that fails to send payment, cover page and waiver form, by this due date can be scratched from the meet at the discretion of the Entry Chairperson.

Entries will be acknowledged within 48 hours of the first date of entry if they are accepted into the meet. *Your entry is considered received only if you receive an acknowledgement.*

ENTRY LIMITS: Athletes may enter a maximum of 5 events each session. This includes relays.

ENTRY FEES:

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chairperson at pbennett@wpi.edu (PLEASE USE YOU Y NAME IN THE SUBJECT LINE). Please check that your team name, address, and contact information are listed correctly in this file. For email entries, payment and hardcopy of the entry (including signed entry cover page and waiver) must be received by: January 21, 2020.

ENTRY TIMES: All entry times must be entered in yard times. (Coach's times should be used instead of NT's for Relays)

RELAYS:

- Teams may enter unlimited relays. Only one relay may score although awards will be given to relays based on place.
- All relay swimmers must be officially entered into the meet.
- Please use Coaches times rather than NT on relays.

TIME TRIALS: Time trials will be offered at the discretion of the Meet Director and the Meet Referee if time allows. Time trials are \$10.00 for individual events, and \$40.00 for relays.

LEGAL SPLITS: Legal splits (including relay lead-offs) must be requested by a coach, before the event, using a legal split form (available from the Clerk of Course) and the requesting party must supply an additional timer(s) on the lane for the split, if necessary, to meet the USA-S requirement.

NO SHOW RULE: There are no penalties imposed on swimmers who fail to compete in any event

ADMISSION: \$5.00 per session for adults 16 years and older. \$3.00 for 15 years and younger.

PROGRAMS: \$3.00 per session

MEET MOBILE Meet Mobile will be functional for this meet, (dependent upon satisfactory internet access), All users should be aware that Meet Mobile publishes unverified raw data that may not always be accurate.

OFFICIALS: If you know that you will be attending this meet, please email the Meet Referee and let him/her know your level of certification, team, and sessions you will be available. This is for pre-meet planning purposes only. All officials are welcome to work any number of sessions and walk-ons are always welcome.

WARM-UPS: Warm up times and lanes may be assigned for all sessions during the meet. Warm up times and lane assignments will be posted on the web site by Wednesday January 22, 2020. There will be warm up lanes available during the meet for warm up and cool down. These lanes are subject to closure at any time if there is misuse or concern for safety. Use of the warm up lanes is at the discretion of the WPI staff. Coaches are responsible for their swimmers at all time in the facility including in the warm up lanes.

SAFETY:

- Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes.
- There will be no diving in the warm-up and warm-down areas at any time
- No shaving is permitted at the competition site.

- No glass containers are permitted within the facility.
- Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, behind the blocks, or in any marked NO CAMERA ZONE.
- Deck changes are prohibited.

MISCELLANEOUS SAFETY:

- Swimmers are required to wear warm-up tops or shirts and shoes when they leave the pool deck. Athletes will not be permitted to leave the pool area without proper dress.
- Parents and Athletes must remain in the pool area, the pool lobby, the overflow viewing area or those access areas. Any individual who is found in the facility outside of permitted use will be trespassed and prohibited from returning to any future meets on campus.

RULES: Current USA Swimming rules will govern all competition. Decisions by the Meet Referee will be final unless a written protest is lodged within 30 minutes of the heat swum. All swimmers, coaches and officials will follow the USA Swimming code of conduct under article 304 of the USA Swimming rules and regulations. Any violation of such policy will be reported to the Meet Referee and the New England Swimming office for further review and/or action.

DRONES Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations.

SAFE SPORT: The conduct of all participants and spectators at a meet is governed by USA Swimming Rules 304/305. Any and all infractions must be reported to an official, the Meet Referee or the Meet Director to be resolved. USA Swimming and NE Swimming encourage all to report any witnessed or suspected forms of abuse/safe sport violations to the NE Swimming Safe Sport Chair, Anne Kaufman: nesafesport@gmail.com (857-928-3638) or through the USA-S online reportable form.

ON DECK PHOTOGRAPHY: As per New England Swimming policy, professional photographers contracted by the Meet Host, or press photographers who have been approved in advance by the Meet Director, are allowed on deck. Use of audio or visual recording devices, including a cell phone, is not permitted behind the starting blocks, including in any spectator area behind the starting blocks, nor in any other marked NO CAMERA ZONE, including on deck. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests

AWARDS: Medals will be awarded for 1st through 8th place in all events. Ribbons will be awarded for place 9 through 20 in all events. Championship plaques will be awarded to team overall boys and girls in all age groups.

SCORING: The meet will be scored through 20 places. Only 4 individuals and one relay per team may score points in each event. Awards will be made based on place.

FOOD: A concession stand may be in operation for the duration of the meet.

VENDOR: A swimming equipment vendor – Varsity Swim Shop – will be selling suits, goggles, and other accessories for the duration of the meet.

MISCELLANEOUS: New England Swimming, WPI and Y-USA assumes no responsibility for lost or stolen property. Pets of any kind and smoking are not permitted within the facility.


