3. Governance Committee: Open positions and timeline for posting & applying:

Six positions will be open to be elected at the HOD meeting in May. These positions include General Chair, Administrative Vice Chair, Performance & Development Vice Chair, Secretary, Junior Coach Representative, and Junior Athlete Representative. The google form for nominations has been posted and the Governance Committee expects to have a slate of nominees for approval prior to the next meeting on April 2.

4. Performance & Development: Championship Season Recap:

Congratulations to the teams who won NES Championship Meets: Arctic Aquatics (10&U), Charles River Aquatics (11-14), and Gator Swim Club (15-19).

There was considerable discussion around the idea that facilities need to be more transparent and concise during the bidding process. Details like whether gym space for overflow is available, if there are usable wedges and backstroke ledges, and plans for parent spectators all should be included in the bid. The Calendar Committee did remind everyone that we don't always have a great deal of choices due to the time of year being

busy for most pools. Patrick suggested expanding our bid form to get more detailed information.

As for as the competition itself, data indicated that the added Gold meet was likely an underlying factor in the Age Group Meets being undersubscribed. Knowing that and with possible goals being a year over year improvement of 4-5%, adjustments in cuts and to the championship meet schedule are both possible.

5. Olympic Trials Plan - Rhi Jeffrey

Planning meetings are underway for an Olympic Trials promotional event involving the entire LSC; teams would be able to be as involved as little or as much as they'd like. Ideas include "good luck" posters, mini camps coinciding with finals on TV, Trials trivia games, and virtual athlete Q&As. The NES website may include a separate "hub" for Trials related content. These Trials focused events will begin as individually run events, not NES run (this will likely make actual implementation easier).

More information will be coming after the next meeting which is planned for 03/13.

6. Sectionals Update

The Sectionals meet at Brown has reached capacity and is closed at 650 individual swimmers and 100 relay-only athletes. With the likelihood of very long timelines in prelims, the entire meet will most likely be A/B flighted.

7. <u>DEI Committee: International Water Safety Day May 14/15</u>

There are two components: USA Swimming International Water Safety Day and, separately, LSC Team Run water safety activities. NES will offer the same support as in the past, including sample activities, promotion on the website, etc.
