**IMPORTANT DEADLINES:**

First date of entry: Tuesday, January 5<sup>th</sup>, 2021

Final date of entry: Thursday, January 7<sup>th</sup>, 2021

Payment deadline: Saturday, January 9<sup>th</sup>, 2021

**ASSUMPTION OF RISK:** We, Seacoast Swimming Association, have taken enhanced health and safety measures – for athletes, coaches, officials, volunteers, and meet management. You must follow all instructions while participating in/spectating at the SSA ESC Dual Meet or on site at the Dan and Kathleen Hogan Sport Center. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable. By participating in/spectating at SSA ESC Dual Meet or and being on site at the Dan and Kathleen Hogan Sport Center, you voluntarily assume all risks related to exposure to COVID-19.

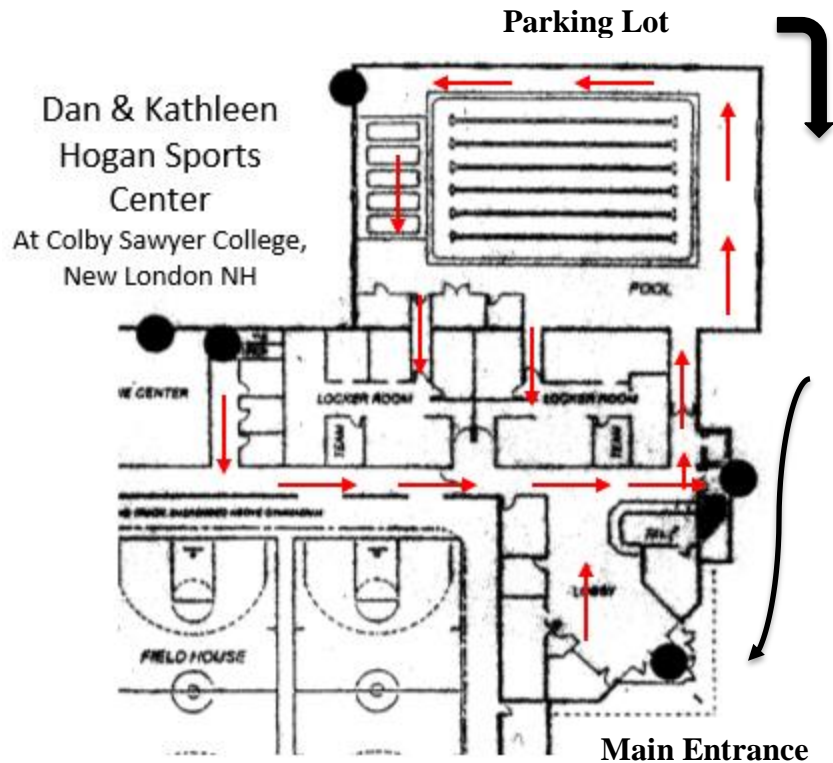

Statement outlining the plan for spectator ingress and egress, use of locker rooms and other facility restrictions in place:

**We will be utilizing a one-way traffic pattern for movement around the pool deck and the surrounding part of the building.** There will also be ample signage to direct movement within the area. **Please carefully review the following building diagram:**

Number of individuals gathering in each area of the facility including all spaces, the pool, deck and spectator seating, and all other areas to be used:

Locker Rooms: Please see below*			



\*Locker rooms will be used as a means of traffic management to exit the deck (to return to the upper bleachers). Use of locker rooms for bathroom needs will be permitted but use of locker rooms for changing is discouraged. Adult participants (coaches, timers, meet management, ect) are to use the bathrooms located in the main lobby.

**Any parent or legal guardian requesting access to their child will be allowed, following all safety guidelines, by contacting Safety Marshal Margaret May at 603-767-5134 or Meet Director Bill Reeves at 603-866-3106.**

**Facility and general precautions:**

- **ALL ATTENDEES swimmers and meet staff included, shall be masked at all times.**
  - Seacoast will provide masks to those that do not have one.
- We will significantly limit the number of personnel needed to run the meet
  - Each visiting team shall have only two coaches on deck per session.
  - There will be no more than 48 swimmers per session in total.
- Three sessions throughout the day: 12 & Under, 13-16 and OPEN
  - Swimmers will be limited to not more than 3 individual swims in session
  - 15 minutes buffer in between sessions will allow the deck to clear and time for facility cleaning.

**Racing:**

- Swimmers will be distantly staged for heats using a spaced bullpen. No more than two heats will be allowed to line up. This will allow an ample space behind the lanes for swimmer approach and exit.

- No ‘fly-over’ starts will be used. Swimmers from the previous heat will be allowed to clear the start area before the next heat is invited forward.
- Hand sanitizer will be placed at the ‘on-deck’ position for each lane. Swimmers can then sanitize before they touch any common surface (block, if used)
- After each race, swimmers will be directed to exit the deck area such that other swimmers can advance.

### **Swimmers On Deck:**

- Swimmers will be distantly seated with their own teams.
  - One team will be positioned on deck and the other will utilize the upper balcony. Teams will be assigned spaces once the entries are in.
- *Swimmers will be required to be masked when not preparing for a race, eating or drinking.*

### **Warm up:**

- Warm up will be conducted in ‘double-wide’ lanes to allow for circle swimming while maintaining a six foot distance at all times.
  - Swimmers are reminded to stay on/over the black lines while they swim; this ensures spacing.
- Warm-ups will be separated by team.
- No more than 24 swimmers will be in the pool during any warm-up.
- Warm-ups will be staggered by 5 minutes such that the pool can be cleared without causing congestion.

### **In-Session Warm Up:**

- If time allows, competitive breaks will be added into the schedule. These will be swum one swimmer per lane and swimmers are asked to be considerate of other swimmers needs as they prep for their races.
- All other ‘normal’ safety rules will still apply (ie, feet first entry, etc).

### **Spectators:**

- In accordance with USA Swimming rules, NO spectators will be allowed on deck
- We strongly discourage spectators from attending the meet (please review Sections 10 and 11 of Safer at Home: Pools, above). There will be a small area of the upper bleachers designated for spectators. **Space is limited to 4 persons.**
  - Any parent or legal guardian requesting access to their child will be allowed as outlined above.
- The pool deck can be viewed through the windows surround the deck.
- Seacoast is committed to providing an open, safe, and transparent competition while also balancing the demands of public health. Extra family members should stay home.

**STATE GUIDELINES:** New Hampshire [Safer at Home: Universal Guidelines](#) and [Safer at Home: Pools](#)

**MEET FORMAT:** The meet will be swum as timed finals. Each session will be PRE-SEEDED, no scratches or deck entries will be accepted. Heat sheets will be available for coaches pick up at the control table. Heat sheets will also be posted at various spots around the pool deck. Swimmers will be reminded to maintain their distance when they check their heat and lane.

No events will swim with more than one swimmer per lane.

**DISTANCE EVENTS:** All distance events (400 yards and longer) will be swum slow to fast in MIXED heats. Timing will be done by those timing the session.

**SITE:** The Hogan Sports Center Competition Pool is a 6-lane, 25-yard pool with 7-foot-wide lanes and non-turbulent lane lines. The timing system includes a fully automatic Colorado Time System electronic timing system with touchpads at the finish end of the pool with single-line electronic display. There are no touchpads at the turn end of the pool. The finish end of the pool is 13 feet deep; the turn end of the pool is 4 feet deep. Spectator seating is for 4 persons. The pool is located inside the Dan and Kathleen Hogan Sports Center, Colby Sawyer College, 541 Main St, New London, NH 03257. Please enter through the main entrance towards the left rear from the parking lot. Directions may be found later in this document.

The competition course has not been certified in accordance with 104.2.2C(4).

**COURSE:** Short course yards (25 yards).

**RESERVE THE RIGHT TO MAKE CHANGES:** Once a meet is sanctioned, changes can be made to the meet invitation before the meet, only with the approval of the Technical Chair, [Patrick Johnstone](#). Any change to the meet format after the meet begins will be at the discretion of the Meet Referee and will be presented to the coaches at a coaches meeting.

**MEET COMMITTEE/ JURY:** The Meet Jury will be made up of one official, one coach, and one athlete to be selected by the Meet Referee who will present issues and moderate the Meet Jury but not vote. When possible, the three members shall be from separate teams. The Meet Jury will decide all issues of eligibility and anything not addressed in the Meet Announcement. The Meet Referee shall have authority as described in the current USA Swimming Rulebook.

**ENTRY POLICY:** 100% Reserved Entry

**CUT PROTOCOL:** If a session is over-subscribed, the Meet Director reserves the right to limit events, heats, swimmers, or adjust the format to conform to the 4-hour rule using the following cut protocols in any order deemed necessary:

- (a.) May be asked to cut each athlete to two less events per day than the maximum allowed.
- (b.) Entries may be cut by time or to a specific number of heats for specified events
- (c.) May be asked to cut relay events.

If deck scratches allow a reasonable time-line, swimmers may be reinstated into those previously entered events. Clubs will be notified of cuts no later than Monday before the meet

**WEATHER PROTOCOL:** If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have a right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is a decision of the Meet Director and the Meet Referee. If weather requires the cancellation of any Finals session, the results of the preliminary session will be the final order.

**ELIGIBILITY:** All swimmers must be currently registered as athlete members of United States Swimming. Age is determined by the age of the swimmer on the first day of the meet.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**SWIMWEAR:** Per USA Swimming rules (102.8.1.F), 12 & Under swimmers may not wear a Technical Suit at any Sanctioned, Approved, or Observed meet. The age of the swimmer is determined on the first day of the

meet. Guidance on identifying compliant and non-compliant suits can be found on the USA Swimming website under [Tech Suit Restriction for 12-and-Under Swimmers](#).

**REGISTRATIONS:** All swimmers must be registered (including proof of age and payment) with USA Swimming before 5:00 pm on the Thursday before the first day of the start of the meet. New England teams are required to check their entries with the online registration check tool on the New England Swimming website to verify registration status. Coaches must be registered before the start of the meet.

**FALSE REGISTRATIONS:** If a swimmer who is not properly registered with USA Swimming competes in a sanctioned competition, the host LSC will impose a fine of up to \$100.00 per event against the individual, member coach, or a member club submitting a meet the entry.

**DECK REGISTRATIONS:** Will not be accepted.

**DECK ACCESS:** Only current USA Swimming registered athletes, coaches, officials, and official meet staff are permitted on the pool deck. All non-athletes on the pool deck must produce proof of their valid USA Swimming registration when asked. Deck Pass is an acceptable proof of membership. Individuals without proof of a valid membership in USA Swimming will be removed from the pool deck and will be fined by New England Swimming of \$100 to the coach, and \$200 to the coach's club.

**DISABILITY SWIMMERS:** Any current athlete members of USA Swimming with a disability, as defined by USA Swimming Rules and Regulations, may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the Meet Referee and Meet Director of any disability prior to competition.

**EVENTS and SESSIONS:** See attached list.

**ENTRY INFORMATION:**

First date of entry acceptance: **Tuesday, January 5<sup>th</sup>, 2021** (any entry received before this date will be considered received **January 5<sup>th</sup>, 2021**.)

Final date of entry acceptance: **Thursday, January 7<sup>th</sup>, 2021**,

Payment due date for all entries: **Saturday, January 9<sup>th</sup>, 2021** Any team that fails to send payment, cover page and waiver form, by this due date can be scratched from the meet at the discretion of the Entry Chairperson.

***Any team that has been entered into the meet but is prevented from attending due to a change in restrictions imposed by state or local health authorities or the facility shall not be responsible for any meet fees.***

Entries will be acknowledged within 24 hours of the first date of entry if they are accepted into the meet. *Your entry is considered received only if you receive an acknowledgement.*

All unattached swimmers must be declared as unattached, on the entry cover sheet, before the meet begins.

Any team who has not paid their meet fees by the start of the meet will be assessed a \$100 fine. If no payment is received after 30 days, the fine is doubled. This fine is payable to Seacoast Swimming Association. Late payment of entry fees may result in future exclusion from meets hosted by our club.

*Any swimmer who is entered with incorrect swimmer information, or an incorrect or no ID, or is unregistered, will be scratched from the meet until corrections are made per the New England policy.*

**ENTRY LIMITS:** Athletes may enter as many events as they choose but may only compete in a maximum of 3 individual events per day for timed final events. Time trials count in the per day event count.

**ENTRY FEES:** Electronic entries:

**\$5.00** for all timed final individual events 200 yards and under.

**\$10.00** for distance events (events 400 yards and over).

**\$10.00** for time trials

**Non-electronic entries: \$5.50 for individual \$10.50 for distance and \$25.00 for relays.**

Swimmer Participation Fee is **\$15** per swimmer.

**NE Swimming Travel Fee of \$1.00 per swimmer** (to be included in the check and the host team will send to NESwimming)

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format should be emailed as an attachment to the entry chairperson at [entries.seacoast@gmail.com](mailto:entries.seacoast@gmail.com) Please check that your team name, address, and contact information are listed correctly in this file. For email entries, payment and hardcopy of the entry (including signed entry cover page and waiver) must be received by: Thursday, January 7<sup>th</sup>, 2021

**ENTRY TIME UPDATES:** Entry times may be updated until the entry deadline. No new entries will be accepted after the entry deadline. Entry time updates should be sent via email to the entry chairperson at [entries.seacoast@gmail.com](mailto:entries.seacoast@gmail.com). Entry time updates must be sent as Hy-Tek format CL2 files with updated times. (New entries will be automatically excluded.)

**ENTRY TIMES:** All entry times must be entered in the specified meet course. (Coach's times should be used instead of NT's)

**TIME TRIALS:** Time trials will be offered at the discretion of the Meet Director and the Meet Referee if time allows. Time trials are \$10.00 for individual events, and \$40.00 for relays.

**LEGAL SPLITS – Individual Events:** Legal splits must be requested before the event, by a coach, using a legal split form (available from the Control Table) and the requesting party must supply an additional timer(s) on the lane for the split, if necessary, to meet the USA-S requirement. (1 timer with touchpad timing, 3 timers without touchpad timing). Timers must be positioned over the lane at the end of the racing course.

**ADMISSION:** No admission will be charged

**PROGRAMS:** Heat sheets will not be available for purchase. They will be posted around the pool deck.

**MEET MOBILE:** Meet Mobile will be functional for this meet, (dependent upon satisfactory internet access) All users should be aware that Meet Mobile publishes unverified raw data that may not always be accurate.

**OFFICIALS:** Officials that know they will be attending the meet are highly encouraged to email the Meet Referee and let him/her know your level of certification, team, and sessions you will be available. Walk-on officials may not be accepted to limit the number of people on the deck. Bill Bond may be reached at [bondyorkme@yahoo.com](mailto:bondyorkme@yahoo.com) and will either conduct a officials meeting virtually in the days before the meet or hold a brief meeting 30minutes before session start during the meet.

**WARM-UPS:** The pool will open for warm-ups as designated on the event list. Please note these times may change as entries are received. Teams will be updated of any changes by Friday, January 8<sup>th</sup>, 2021

- Warm up will be conducted in ‘double-wide’ lanes to allow for circle swimming while maintaining a six foot distance at all times.
  - Swimmers are reminded to stay on/over the black lines while they swim; this ensures spacing.
- Warm-ups will be separated by team.
- No more than 24 swimmers will be in the pool during any warm-up.
- Warm-ups will be staggered by 5 minutes such that the pool can be cleared without causing congestion.

**SAFETY:**

- Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- No shaving is permitted at the competition site.
- No glass containers are permitted within the facility.
- Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, behind the blocks, or in any marked NO CAMERA ZONE.
- Deck changes are prohibited.

**MISCELLANEOUS SAFETY:** *Please carefully review the points listed in the section titled “SAFETY PROTOCOLS DUE to COVID RESTRICTIONS.”*

**RULES:** Current USA Swimming rules will govern all competition. Decisions by the Meet Referee will be final unless a written protest is lodged within 30 minutes of the heat swum. All swimmers, coaches and officials will follow the USA Swimming code of conduct under article 304 of the USA Swimming rules and regulations. Any violation of such policy will be reported to the Meet Referee and the New England Swimming office for further review and/or action.

**DRONES:** Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations.

**SAFE SPORT:** The conduct of all participants and spectators at a meet is governed by USA Swimming Rules 304/305. Any and all infractions must be reported to the Meet Referee or Meet Director.

All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

USA Swimming and NE Swimming encourage all to report any witnessed or suspected forms of abuse/safe sport violations to the NE Swimming Safe Sport Chair, Anne Kaufman: [nesafesport@gmail.com](mailto:nesafesport@gmail.com) (857-928-3638) or through the [USA-S online reportable form](#).

**ON DECK PHOTOGRAPHY:** As per New England Swimming policy, professional photographers contracted by Seacoast Swimming Association, or press photographers who have been approved in advance by the Meet Director, are allowed on deck. Use of audio or visual recording devices, including a cell phone, is not

permitted behind the starting blocks, including in any spectator area behind the starting blocks, nor in any other marked NO CAMERA ZONE, including on deck. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests

**AWARDS:** There will be no awards.

**SCORING:** The meet will not be scored.

**FOOD:** Seacoast will not be running any type of concession stand. Colby Sawyer may or may not offer a concessions area. Participants are advised to plan ahead and bring their own foodstuffs.

**VENDOR:** No vendor will be present.

**MISCELLANEOUS:** New England Swimming and Seacoast Swimming Association assume no responsibility for lost or stolen property. Pets of any kind and smoking are not permitted within the facility.

**PARKING:** Ample parking is available adjacent to the Sports Center. Please note the member and public designated spots.

**DIRECTIONS.** The Colby Sawyer Dan and Kathleen Hogan Sports Center is located at 541 Main St, New London, NH 03257 and easily accessible from NH RT 89. The pool is approximately 85 minutes from the Dover Indoor Pool and 55 minutes from the Executive Health & Sport Center of Manchester.
