SITE	The Simmons College Competition Pool is an 8-lane, 25-yard pool with 7-foot-wide lanes and nonturbulent lane lines. The timing system includes a fully automatic Daktronics Time Systems electronic timing system with touchpads at the finish end of the pool with an 8-lane electronic display. There are no touchpads at the turn end of the pool. Attached to the main pool is a diving well area that is available for warm-up and warm-down, approximately 3 lanes x 20 yards in size. The finish end of the pool is 13 feet deep; the turn end of the pool is 4 feet deep. Spectator seating is for 150. The pool is located inside the Holmes Sports Center at 331 Brookline Avenue, Boston, MA 02115. Please enter through the main entrance on Brookline Avenue. Directions can be found later in this document. The competition course not been certified in accordance with 104.2.2C(4).
COURSE	SCY
FORMAT:	 The meet will be swum Prelims and Finals on Saturday and Sunday for the 13&Over group and the 11/12 age group. All 10&Under Events are timed finals The Finals will comprise of 1 heat for the 11-12 age group for all events. There will be 3 heats (A/B/C) for the 13&Over age group with the C final protected to 13-14, except for the 400 IM and 500 free will swim 1 heat. Eight competition lanes will be used in the evening finals sessions. No events will swim with more than one swimmer per lane. DISTANCE EVENTS: The 1650 will swim fastest to slowest mixed gender 25-yard events will start at start end and will be timed with 3 watches
SCRATCHES	• Scratch sheets will be used for all sessions and must be turned in at the control table 30 minutes before the start of each session.

	• There will be no penalty for missed events during prelims. Any swimmer that qualifies for finals and doesn't properly scratch will be fined \$25.00 payable to the host team.
ELIGIBILITY	• All swimmers must be currently registered as athlete members of USA Swimming (USAS) before 5:00 pm on the day before the first day of the meet. New England swimmers must have a "proof-of-age" document on file by the above deadline in order to compete.
	Age is determined by the age of the swimmer on the first day of the meet.
	• Any swimmer entered in the meet must be certified by a USAS Member-Coach as being proficient in performing a racing start or must start each race from within the water without the use of the Backstroke ledge. When unaccompanied by a Member-Coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
	Coaches must be registered before the start of the meet.
	• If a swimmer who is not properly registered with USAS competes in a sanctioned competition, the host LSC will impose a fine of up to \$100.00 per event against the individual, member coach, or a member club submitting the entry.
	Deck Registrations will NOT be accepted.
DISABILITY SWIMMERS	Athletes with a disability are welcome; they, or the athlete's coach, shall provide advance notice of desired accommodations to the Meet Director.
	• The athlete, or the athlete's coach, is also responsible for notifying the Meet Referee of any disability prior to the competition.
ENTRY POLICY	First Come, First Serve (FCFS) ■ The host team may reserve entries only for their own team.
	• Entries will open at 12:00am on the first date of entries
	Entries received at the same clock second shall be considered tied in sequence with any other entries received on that clock second.
	• Entries received before the first date of entries shall be considered tied in sequence require resolution, a lottery will be conducted by the New England Swimming office. The results of the lottery will be shared with all involved parties.
CUT PROTOCOL	If a session is over-subscribed, the Meet Director reserves the right to limit events, heats, swimmers, or adjust the format to conform to the 4-Hour Rule using the following Cut Protocols in any order deemed necessary:
	Teams may be asked to cut each athlete to no more than two fewer events per day than the maximum allowed.
	 Entries may be cut by time, or to a specific number of heats, for specified events. Teams may be asked to cut relay events.
	If deck scratches allow a reasonable timeline, the swimmers can be reinstated into those previously
ENTRIES	 entered events. Clubs will be notified of cuts no later than Monday before the meet. Electronic entries should be emailed as an attachment to the Entry Chairperson. Please check that your team's name, address, and contact information are listed correctly in this file. For email entries, payment and hardcopy of the entry (including signed Entry Payment and Liability Release Form) must be received by 11/21. Failure to pay Entry Fees by this deadline could result in teams being barred from the meet.

	• Any team that fails to send the Entry Payment and Liability Release Form as well as payment by the aforementioned date may be scratched from the meet and may be assessed a \$100 fine at the discretion of the Entry Chairperson. If no payment is received after 30 days, the fine is doubled. This fine is payable to NKE Swim . Late payment of entry fees may result in future exclusion from meets hosted by our club.
	• Entries will be acknowledged within 24 if they are accepted into the meet. <i>Your entry is considered received only if you receive an acknowledgement.</i>
	• All Unattached swimmers must be declared as "Unattached" on the Entry Payment and Liability Release Form before the meet begins.
	• All Entry Times must be entered in the specified meet course. Coach's times may be used (and are preferred) instead of "NT" Entry Times.
	• Athletes may enter as many events as they choose but may only compete in a maximum of 6 individual events per day for timed final events(10 & Under), or 3 individual events per day for trial/finals (11 & over) Time trials count in the per day event count.
	• ENTRY TIME UPDATES: Entry Times may be updated until the Monday prior to the first day of the meet (11/17). No new entries will be accepted after the Final Date of Entry Acceptance; they will be automatically excluded from Entry Time Update files. Entry Time Updates must be sent via email to the Entry Chairperson in Hy-Tek format.
	No deck entries will be accepted.
TIME TRIALS	Time Trial events will be offered at the discretion of the Meet Director and the Meet Referee.

	• Non-electronic entries: \$5.50 for individual, \$10.50 for distance and \$25.00 for relays.
MEET MOBILE	MEET MOBILE HEAT SHEETS Meet Mobile heat sheets will be offered at this meet for Free. The Meet Mobile heat sheet includes smart phone access to all heat sheets for the whole meet, including last minute changes and re-seeds.
	MEET MOBILE: Meet Mobile will be functional for this meet, (dependent upon satisfactory internet access) All users should be aware that Meet Mobile publishes unverified raw data that may not always be accurate.
WARM-UP	The pool will open for warm-ups as designated on the event list one-hour before the beginning of each session. The pool will close five minutes before the beginning of each session. Teams will be assigned warm-up lanes after all entries are received. The diving well area will be available during the meet for warm-up and warm-down. See "Safety" for Warm-up safety guidelines.

LEGAL SPLITS	Individual Events: Preferably, Legal Splits should be requested before the event, by a coach, using a Legal Split Form (available from the Control Table), and the requesting party should supply an additional timer(s) on the lane for the split, if necessary, to ensure an accurate time (one timer with touchpad timing, three timers without touchpad timing). Timers must be positioned over the lane at the end of the racing course. Optionally, a Legal Split may be requested after the event using a Legal Split Form when using a fully automatic timing system. The Admin Official has discretion to either grant or deny the request after reviewing the available evidence. Backstroke Legal Splits must be requested in advance to ensure a legal finish.
SWIMWEAR	Per USA Swimming rules (102.8.1.F), 12&Under swimmers may not wear a Technical Suit at any Sanctioned, Approved, or Observed meet. The age of the swimmer is determined on the first day of the meet. Guidance on identifying compliant and non-compliant suits can be found on the USA Swimming website under <u>Tech Suit Restriction for 12-and-Under Swimmers</u> .
RULES	 The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Protection Policy (MAAPP 2.0) will govern this meet. Operation of a DRONE, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USAS approval. Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is not permitted. PHOTOGRAPHY: As per NES policy, professional photographers contracted by M.F. Swimming, LLC, or press photographers who have been approved in advance by the Meet Director, are allowed on deck. Use of audio or visual recording devices, including a cell phone, is not permitted behind the starting blocks, including in any spectator area behind the starting blocks, nor in any other marked NO CAMERA ZONE, including on deck. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests. VIDEO STREAMING: All video streaming must be approved in advance by the Meet Director. Any such video stream must conform to all current SafeSport policies defined by USAS, NES, and the Meet Host. No video stream may originate from behind the starting blocks or from any other area marked as a NO CAMERA ZONE. Deck Changing is PROHIBITED. An athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider. According to NES Best Practices, all athletes should shower before entering the pool. In accordance with NES Policy, only those coaches who have current, valid USAS credentials will be permitted to act in a
SAFETY	 credentials will be required to leave the deck area. No shaving is permitted at the competition site. No glass containers are permitted within the facility.

• Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the Meet Referee before he/she warms up, and the Meet Referee will assign the swimmer to a registered coach for warm-ups.

WARM UP SAFETY:

- Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time.
- For all warm-up sessions, swimmers must utilize a "sit-and-slide"/"three-point" entry to enter the pool for warm-ups, by first sitting on the deck, and then sliding, feet-first, into the pool.
- In extraordinary cases, due to bulkheads and other pool designs, it may be determined that it is unsafe or impossible for swimmers to perform the required sit and slide entry. In such extremely rare cases, the sit and slide rule may be modified. Exceptions to the sit and slide rule shall only be made when performing the sit and slide entry poses risk of injury to swimmers and/or risk damaging or ripping of swimsuits. An exception to the sit and slide rule shall only be made when the Safety Monitor, Meet Director, and Meet Referee have evaluated the risks and unanimously determined that the use of the sit and slide entry poses such great risk as to be unsafe. In these cases, the Safety Monitor, Meet Director, and Meet Referee must determine and agree upon an alternative safety plan to ensure swimmer safety.

SAFE SPORT

- The USA Swimming SafeSport program is USAS's comprehensive abuse prevention program
 dedicated to creating a healthy and positive environment free from abuse for all its members.
 Components of the program include, but are not limited to, providing education and training,
 enforcing policies (such as the Minor Athlete Abuse Prevention Policy), rules and best practice
 guidelines, promoting healthy boundaries and mandatory reporting of violations.
- The Minor Athlete Abuse Prevention Policy prohibits Adult Participants (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult participant. Adult Participants are required to abide by this policy in full during this meet.
- Pursuant to <u>USAS Rules and Regulations and</u> federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. A report to the U.S. Center for SafeSport may be made via telephone at 833-5US-SAFE (833-587-7233), or via online at www.uscenterforsafesport.org/report-a-concern. Various state laws may also require reporting to law enforcement or to a designated child protection agency.
- For information on how to report other alleged violations, including without limitation the Code of Conduct found within the USAS Rules and Regulations as well as the Minor Athlete Abuse Prevention Policy, please visit www.usaswimming.org/report.
- All athletes age 18 and older must complete <u>Athlete Protection Training</u> in order to be a USA Swimming registered member in good standing. Any athlete who turns 18 on or after 11/21, who has not completed Athlete Protection Training by the first day of competition, will be prohibited from participating in the competition until such time as all membership requirements are completed. Times achieved by an athlete who turns 18 on or after 11/21, who competes in this USAS sanctioned event without completing this requirement, will NOT count for qualification or recognition. This includes participation as a member of a relay.

CHANGES TO MEET	Once a meet is sanctioned, changes can be made to the Meet Information before the meet only with the approval of the Co-Technical Chairs, <u>Patrick Johnstone</u> and <u>Greg Gowern</u> . Any change to the Meet Format after the meet begins will be at the discretion of the Meet Referee, and will be presented to the coaches at a coaches meeting.
WEATHER/ FACILITY PROTOCOL	If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have a right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is the decision of the Meet Director, Meet Referee, and the Meet Jury.
MEET JURY	The Meet Jury will be made up of one official, one coach, and one athlete to be selected by the Meet Referee who will present issues and moderate the Meet Jury but not vote. When possible, the three members shall be from separate teams. The Meet Jury will decide all issues of eligibility, and anything not addressed in the Meet Announcement. The Meet Referee shall have authority as described in the current USA Swimming Rulebook.
DECK ACCESS	Only current USA Swimming registered athletes, coaches, officials, and official meet staff are permitted on the pool deck. All non-athletes on the pool deck must produce proof of their valid USA Swimming registration when asked. Individuals without proof of a valid membership in USA Swimming will be removed from the pool deck and will be fined by New England Swimming of \$100 to the coach, and \$200 to the coach's club.
OFFICIALS	Officials that know they will be attending the meet are highly encouraged to email the Meet Referee and let him/her know your level of certification, team, and sessions you will be available. Officials meetings will be at least 30 minutes prior to the start of a session or conducted virtually in the days before the meet.
GENERAL	There will be no vendor on site, concessions will be available on a limited basis
DIRECTIONS	The pool is located inside the Holmes Sports Center at Simmons College, 331 Brookline Avenue, Boston, MA 02115. The best GPS address for drop off is 95 Pilgrim Road, Boston, MA 02115
WAIVERS	USA Swimming, Inc., New England Swimming, Inc., NKE Swim, and Bluefish Swim Club cannot prevent you (or your children) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming/New England Swimming sanctioned events. It is not possible to prevent the presence of the disease.
