- 3. New Governance Committee Chair: March 1st McKay Larsen will assume the role of the Governance Committee Chair. <u>Cathy Vaughan</u> will continue as a member of the Governance Committee through the end of her term this year.
- 4. Susan Winter has resigned from the Governance Committee, effective at the end of this Short Course season. There are too many other demands in her life right now. We are deeply grateful for her service, insights, and help on the committee. The board orientation she developed and used has been and will continue to be a great asset to current and future LSC leaders. We wish her the best. She will be missed!

Current Governance Committee Goals

- 1. **Increase the consistent "coach voice" in Utah Swimming decision-making**. Action Steps for Governance Committee Board Partners (Ron Lockwood is the point person)
 - Ensure board members, including the Age Group and Senior Chair and the Coach Rep send a committee member to the board meetings if they are unable to attend.
 - Ensure the Age Group, Senior, and Coaches Committees meet monthly.
- 2. Support Trent in leading the Board to get a meaningful and working Strategic Plan in place by June 2023. Action Steps for Governance Committee Board Partners (All)
 - Cathy and McKay met with Trent on Jan 30
 - Governance Committee Board Partners encourage their board counterparts to review the Strategic Plan and submit meaningful changes and/or additions to the board to review.
 - NOTE: The Board and possibly other LSC leaders will be meeting with Jane Grosser (or another rep from USA Swimming) in the fall, possibly October. Because of the demands at the end of the Long Course season and the beginning of the Short Course season, this is why the Strategic Plan needs to be updated before the end of June.
- 3. Complete a bi-annual review of the LSC Policies and Procedures before the end of March. See if the LSC is in compliance. If not, make a plan to become so.
- **4.** Facilitate the transition of Governing Document maintenance to one of the contractors and Governing Document oversight and management to another member of the Governance Committee by the end of 2023.
