## Items:

- 1. Tom is the new Championships Committee Chair, as per Policies and Procedures Rule 50, page 23 in the P & P manual.
  - a. 9.1.5. Chair 1. Term: August July (or the end of the Long Course State Championships, whichever comes last) 2. Personnel: Alternates by position and year Senior Vice Chair: Beginning August of odd years Age Group Vice Chair: Beginning August of even years.
- 2. There is some confusion about whether Tom or Mike know about this change. Tom's partner member from this committee will make sure they know. His partner is Susan.
- 3. Stan was asked to ask Mike to call a Senior Committee meeting soon. Two possible items for the agenda include a) Discuss possible changes to the reimbursements for Senior swimmers and for Diversity swimmers swimming at out-of-state championship meets. Those changes were discussed at a recent Board meeting (Jan. 2020). Mike and Ezra said they would talk about it. It was suggested that perhaps the committee could help with this. b) Find out what the committee can do to help Mike. He has a lot going on right now.
- 4. Training of the new Board member, and new members of the Admin Board of Review.

- 5. Ideas in progress for helping Board members.

## 6. House of Delegates feedback.

- b. It was felt that the voting process was much more diverse and transparent than in past years, due to early recruitment of candidates for election.
- c. It was noted that, after all was said and done, new ARB members were familiar faces in the Utah Swimming Community, and lesser known, 'new' people were largely not elected. Everyone was pleased with the members of the new ARB, and it was felt that it was reasonable diverse as far as the areas of the state were concerned. Ideas were generated to help with this in future elections:
  - i. Gather more complete bio material and send it out more often and sooner.
  - ii. Have the nominees speak to their qualifications and desires as the HOD.
  - iii. Stan will write "Thank You's" to all ARB candidates who were not elected.

- a. It was agreed that Paul is responsible for training the ARB, according to the LSC policy.
- b. Many current Board members now have LSC credit cards for expenses that have been only "reimbursable" in the past. Stan will make Nikki aware of this in the training and point her towards Serena to get more information.
