## National Certifications and Opportunities

- The new USA Swimming AO training and test have been online as of October 1, 2024.
- The new USA Swimming Starter training and test also has been online as of October 1, 2024.

- Information for junior stroke and turn officials is on the website; will use the same training document we have posted for stroke and turn officials.
- All new officials need to take the new Foundations Course as well that is online.
- Reminder that anyone wanting to advance to Referee must become a certified AO prior to starting Referee training.
