 - o Nationals is that week and Junior Nationals is the following week. So, we may need to wait to solicit out of state evaluators if we make this meet an OQM.

Officials Training and Clinics

- We will determine dates for S&T and AO training for end of August/early September and get those posted.
- We need to update both checklists for S&T and AO now that the certification tests are back online at USA Swimming (removed the old test links from our webpage).
 - o Remind trainees to get registered as a non-athlete member soon after starting training (apprentice official status expires in 60 days).
- Need to place instructions online so that referees know the steps for training (number of hours) and that the officials chair needs to be notified of planned final observations.
- Continue to have set months for officials' trainings, and plan to do them at least quarterly; will continue to do them virtually to allow those from across the state to attend.
 - Planned months of offering training clinics: August/September, October/November, January, and April/May.

Mentoring

 Goals: to get more of our senior officials trained as mentors and utilize our mentors and officials to help recruit more officials for Utah Swimming and more Utah officials working national meet decks to gain experience.
