Volunteer Agreement



ALL EAC FAMILIES ARE REQUIRED TO VOLUNTEER.

Volunteers play a vital role in Elizabethtown Aquatic Club. EAC swimmers are privileged to participate in swim meets because of parent and guardian volunteers. There are plenty of opportunities to volunteer as there are approximately 48 volunteer roles to fill per home meet, 24 roles to fill per away meet, 96 roles to fill at the Frosty Frolic as well as opportunities to help on the board, or with sponsorship, Frosty Frolic, or banquet committees. Volunteer credits are awarded as follows:

- Executive Board (President, Vice President, Treasurer, Secretary) = All volunteer credits regardless of number of swimmers on the team.*
- Active Board Member (attends 80% of meetings) and/or Committee Chairs = 3 volunteer credits*
- Active Committee Member (attends 80% of meetings) = 2 volunteer credits*
- One volunteer job signed up via TeamUnify = 1 volunteer credit **

Anyone that does not meet the 80% attendance threshold for the executive board, board member, committee chair or committee member positions forfeits the volunteer credits.

Volunteers are responsible to check in at the volunteer staging area at every meet and must COMPLETE the job they signed up for to receive the volunteer credit.

Volunteer Requirements

1. Parents/guardians must volunteer for a minimum of two dual meet volunteer slots including CPAL dual meets, divisionals and all-stars per swimmer per season. If you choose not to volunteer, your account will be billed \$50 per swimmer per volunteer spot in lieu of your responsibilities. If any portion of your fee remains unpaid, it will need to be paid before registration for the next season is approved. For example, if you have two children swimming with EAC, you are responsible for volunteering for four spots during the season. If you choose not to volunteer, your account will be charged \$200 (4 slots x \$50).

AND

2. Parents/guardians must volunteer for one adult slot per family during EAC's annual fundraising invitational, the Frosty Frolic. If you choose not to volunteer for the Frosty Frolic, your account will be billed \$50 in lieu of your volunteer responsibilities. Your swimmer(s) will not be able to declare for any championship meets (including, but limited to, divisionals, all stars, 10 & under championships, senior champs, junior champs, silver champs) until this fee is paid.

If your family is unable to volunteer due to hardship or extenuating circumstances, please contact the volunteer coordinator to discuss additional ways that you can support EAC.

Volunteer Criteria

Every volunteer must be able to meet the criteria listed below. You affirm that you should not be disqualified from volunteering based on the conditions listed below:

1. I am not named in the statewide database as a perpetrator of a founded report committed within the last five years.

- 2. I have not been convicted of any of the following at any time in the past: criminal homicide; aggravated assault; stalking; kidnapping, unlawful restraint; rape; statutory sexual assault; involuntary deviate sexual intercourse; sexual assault; aggravated indecent assault; indecent assault; indecent exposure; incest; concealing death of child; endangering welfare of children; dealing in infant children; prostitution and related offenses; obscene and other sexual materials and performances; corruption of minors; sexual abuse of children; or the attempt, solicitation or conspiracy to commit any of the above offenses.
- 3. I have not been convicted of an offense similar in nature to the crimes listed above under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation or under a former law of this Commonwealth.
- 4. I have not been convicted of a drug or drug-related felony in the past five years, including felony convictions under the Controlled Substance, Drug, Device and Cosmetic Act.

I understand, agree to, and accept the EAC volunteer requirements and criteria as stated above.
