Paul Monyok – Review of Technical Report – committee met to discuss use of Colby for summer meet, coaches and athletes recommended moving forward with this.

Per discussion between Paul & Mary Ellen, summer schedule seems acceptable

Holly – Review of Finance Report –

As of reconciliation:

\$141,901.72 in assets (checking, savings, CD)

\$15,000 credit card, which has been used regularly, and has resulted in \$500 wotrh of points over the course of the fiscal year.



Budget vs. actual Profit & Loss- expected \$55,210 deficit, however, due to increased registration and unexpectedly high meet participation, actually ended the last fiscal year \$450 in the black. Also contributing to this was the fact that there were very few community grant requests, and very little athlete travel.

Taylor – New Business

Two Items.

1) Proposed by-law change, procedural change to approval of athlete members to the Athletes Committee.

Sponge – Move to accept. Holly – Second. Approved unanimously

- 2) Mary Ellen discussed proposed USA Swimming legislation
  - a. Standardize the number of meet marshals minimum of 2 per meet, one of each gender
    - Discussion Sponge questioned validity of two gender approach, Zach noted that the primary goal is locker room safety
    - ii. Meet marshals will still be volunteers with no requirement that they be registered.
  - b. Proposed changes to the transfer rule from 120 days to 30 or 60 days

 Taylor discussed rationale – unfair to swimmers who move (i.e., military families), or to those with reasons to move teams immediately (bullying, etc.) Old rule had no consideration for the cause of the move, was primarily in place to prevent club hopping.

Mary Ellen – New SWIMS 3.0 platform to be rolled out, and effective 9/1/2022. SWIMS 2.0 is outdated. Under new system, swimmers will register with club, then be provided a link to SWIMS 3.0. Parents will then create and account and register the swimmers on SWIMS 3.0 (Birth date ID being replaced with 14-digit ID to preserve privacy.) Links are "club-specific," and should not be shared. Payments will be made on SWIMS 3.0, directly to USA Swimming, who will then distribute LSC funds back to MESI. All team transfers, will be handled via SWIMS 3.0.

Mary Ellen will provide Zoom training, dates TBD.

Swimmers/families will likely have access to SWIMS 3.0 to set up profiles prior to 9/1/22, but data will not become live until 9/1/22.

Meet fees will still be handles outside of new system.
