MAINE SWIMMING 2022021 CLUB FINANCIAL SUPPORT PROGRAM

The MAINE SWIMMING 2022021 CLUB FINANCIAL SUPPORT PROGRAM hed to provide aid to clubs who are in need of financial assistance as a result of the COVID-19 pandemic. MESI clubs may apply for funding for the following categories:

LEVE1 Dire immediate need to keep clubs viable

LEVEL 2 Funding for continued successful operation of clubs through ongoing pandemic

TIERS [Total aid disbursed will not exceed \$11,000 for the 2020 - 2021 fiscal year ending August 31, 2021.

Funding will be broken down into the following tiers:

TIER 1 Rebate of 2021 Club Registration fee collected from the club of up to, but not exceeding, \$130 for year-round registrations and up to, but not exceeding, \$100 for Season 1 registrations.

TIER 2 (Tlubs who were awarded bids for club-hosted meets scheduled during the 2020 - 2021 Short Course and Long Course seasons (as approved by the MESI House of Delegates during the 2020 Annual Meeting) that are canceled due to the COMD-19 pandemic may be rebated a portion of the anticipated meet entry fee revenue for this year's meet in amounts up to, but not exceeding, 60% of the total meet entry fees collected for this same meet during the 2019 - 2020 season as disclosed on the required Meet Financial Report and Team Entry Fee Report.

TIER 3 Clubs who were awarded bids fetroletes Imeets scheduled between September 1, 2020 and March 31, 20 (as approved by the MESI House of Delegates during the 2020 Annual Meeting) and who will be unable to resche meets prior to the end of the 202021 season due to the CONDENDAMENT may be rebated in amounts up to, but not exceeding, 75% of the total club income collected for this same meet during 202020seasour up to, but not exceeding, 75% of the total club income collected for this same meet during the 2020 season.

ELIGIBILITYM order to be eligible to apply for this financial assistance, clubs must:

- Be currently registered and in good standing with MESI;
- Show demonstrable current and anticipated financial losses as a result of the economic impacts of the COMD-19 pandemic (e.g., Profit & Loss financial statement for current and prior fiscal years; Profit & Loss actual vs. budget comparison for current and prior fiscal years, current bank statements, etc.);
- Show proof of application for any and all local, state, and federal assistance including, but not limited to, the Small Business COMD-19 Economic Injury Disaster Loan program, the Payroll Protection Program, and any other grant/loan opportunities, if eligible;
- Disclose the amount and type of any and all funds received through local, state, and federal assistance including, but not limited to, the Small Business COMD-19 Economic Injury Disaster Loan program, the Payroll Protection Program, USA Swimming's COMD-19 Relief Program for Teams, MESI's Club Financial Support Program, and any other grant/loan opportunities;
- Have incurred continued operating expenses, excluding payroll; and
- Provide a comprehensive long-term viability plan, including an amended budget reflecting the use of received and/or
 expected grants and other available resources.

APPLICATION 3 pplication for financial assistance must be made on the form designated for this purpose.

APPLICATION REVIEWS TOP RATIONS & quests will be considered individually with strongest consideration given to those

requests that demonstrate the greatest need as determined by the Finance Committee. In evaluating applications, the Committee will consider the following:

- If clubs have achieved Safe Sport Club Recognition status;
- If clubs have achieved USASwimming Club Recognition status;
- If clubs have provided documentation of demonstrable financial losses as a result of the economic impacts of the COVID-19 pandemic;
- If clubs have submitted all necessary forms, reports, and fees as outlined in Section 1000 of the MESI Policies and Procedures for the 2019 2020 and 2020 2021 seasons;
- If clubs have shown a long-term ability to return to operation through their comprehensive return to viability plans;
- If clubs have exhausted their reserves; and
- If clubs have received outside funds and/or have identified opportunities and initiated plans to secure additional funds through local, state, and federal assistance.
