  - OMULTIPLE MINOR ATHLETES
    - MUST INCLUDE AT LEAST TWO ADULT PARTICIPANTS

## ATHLETES' COMMITTEE DUTIES

"THE ATHLETES' COMMITTEE SHALL HAVE GENERAL CHARGE OF THE BUSINESS AND AFFAIRS OF THE ATHLETES OF MESI AND SHALL UNDERTAKE SUCH ACTIVITIES (A) DELEGATED TO IT BY THE BOARD OF DIRECTORS OR THE GENERAL CHAIR OR (B) UNDERTAKEN BY THE COMMITTEE AS BEING IN THE BEST INTEREST OF THE ATHLETE MEMBERS, MESI, USA SWIMMING, AND THE SPORT OF SWIMMING" - MESI BYLAWS, ARTICLE 7.4.1.C
