Aid determinations for Round 1 will be completed by the Finance Committee by December 7, 2021. |

Senior Scholarship

Motion by Jim to approve a \$4,000 scholarship per year for the Emily Caras Snyder Scholarship, second by Taylor

Round 1 disbursements are expected to be distributed by December 14, 2021."

Discussion: The family has stated they would like to give \$1,500 a year instead of the original \$500, so MESI's investment each year has not changed – MESI will still give only \$2,500 for Emily Caras Snyder Scholarship with the family giving \$1,500 *All in favor, motion passes unanimously*

Observation Fees

Request for funds (\$1,200) to reimburse the official's \$50 each to attend High School State Meets and Regional Meets

Discussion: How will that be divided? 8 Regional Meets, 4 High School State Meets, 2 officials per meet = \$1,200

Mary Ellen – Would we want to up the amount to cover more officials? One official can't adequately cover an entire 8 lane pool, possibly have 4 officials at some State Meets

Would this come out of the Senior Committee Budget? Senior Committee Budget is at \$1,000 – Jim would like to increase the budget to \$1,600 to cover the cost of the observation fees

Motion by Jim to recommend to the Board to increase the Senior Committee's Budget to \$1,600 to cover the cost of paying officials \$50 each to attend High School State Meets & Regional Meets, second by Mary Ellen

All in favor, motion passes unanimously
