SENIOR CHAIR/AGE GROUP CHAIR REPORT - Mike Schmidt A report on what I accomplished this year in these dual roles is going to be brief. I spent my entire tenure in both positions being reactive and not proactive. I can think of two instances where I actively contributed, from the Senior Chair perspective, that would be in the modification of the prompt for the senior scholarship application, and from the Age Group Chair perspective, it would be in the planning of the 10 and under all star clinic. In each of these instances I was helped along by others who were much further along in the process than I was, so I make no claim to any accomplishment in my first year.

I did learn some things about MESI governance during my first year. Senior Chair is on most of the committees, and if not on for that position, then Age Group Chair is also on most of the committees. The committee work provided me with some insight into how things get done, and an appreciation for Jim, Jay, Taylor, Marie and Mary Ellen who do the lion's share of the work in making sure things move forward, events take place and we have a swim season each year. With all this committee experience, I think I was asked two questions about my board work, both pertaining to the banquet, a committee I wasn't on.

As the year went on I had moments where I would ask myself what exactly am I supposed to be doing, aside from logging into whatever committee I got Zoom link to attend. I looked at the job descriptions for each position in the By-Laws and the New Board Member Orientation Manual, which wasn't time consuming since they both say the same thing which is that I have "general charge over the division". Not sure what that means from an operations perspective, but it sounds good. Even with having "general charge" over two divisions I still didn't know what I was supposed to be doing or how I could help, other then continuing to log on when I got the Zoom invitations.

I went back and read all the HOD minutes going back to 2003 to see if the yearly reports from the respective chair positions would give me an indication on what I

That's when I learned that part of our strategic planning had been to establish some type of training opportunity for senior level swimmers. I do have some thoughts about how this can be done in a meaningful way to prepare some of our senior swimmers for National level competitions, and in particular to enhance the opportunity for some of our swimmers to make Olympic Trial cuts (which I saw was also part of our 4 year plan). This would be to look to provide what we can't provide, and that is 3-4 opportunities over the next year for swimmers on this track to have short training trips where they can get in some long course training in preparation for a meet or meets where they are going to attempt to make a OT cut. I think the process for starting a committee to work under the Senior Chair position has or is already being contemplated, and I would like to see this authorized and undertaken over the summer so that a plan can be proposed by the committee to aid some of our senior swimmers in this objective for the 2019-2020 season.

Please accept this as my report for the 2018-2019 season, and to the extent it did not fit the proper form for a report I would only add that having "general charge" has it privileges.

SAFE SPORT CHAIR Matt Montgomery UPDATES

We had a table with Safe Sport material in the field house at UMO during the Maine Winter Championships to help raise awareness of the program among our members.

INCIDENTS

We had one Safe Sport incident this past season that was reported to the National Office. Though ultimately nothing was deemed inappropriate to have occurred, we did learn some very important things:

Meet Officials: If it is determined that an interview of athletes needs to be conducted, do so in the presence of the athlete's coach or parent and with meet staff of the other gender.

Coaches: If your team is sharing a lane with another team during warmups (especially those from another LSC), speak to your athletes about lane etiquette. What may be acceptable on your team when passing a swimmer (ie. Physical contact like grabbing ankles) may not be appropriate with swimmers from another team. *REMINDERS*

All clubs are required to have the following:

- • A Club Safe Sport Representative. It is recommended that this person not be the Head Coach.
- • An action plan to address bullying.
- • An electronic communication policy.
- • A team travel policy.

Templates from all of these policies are available on the Maine Swimming website under the "Safe Sport" tab, as well as other useful information for running meets, including Pre-Meet Risk Assessment and A Resource Guide for Safe Sport at Meets.

OPEN WATER:

An LSC championship would need to be in late August after sectionals; in past Seals open water event drew 100-150 swimmers, mostly masters, instate.

OPERATIONAL RISK Zach Mullin

Maine Swimming had a safe year in regards to Operational Risk.

Notable occurrences are the safety precautions taken with backstroke wedges during warm ups. Kids are instructed to only use them during sprint lane designations, as to avoid the wedges flying into another swimmers face.

I did receive a spreadsheet a few months ago from USA Swimming with numbers of injuries based on LSCs. Maine, alongside many other small LSCs, does not seem to be reporting injuries. We are either really safe or not feeling it necessary to report. I know that for my team, all incident reports are filed with the YMCA and I'm

assuming most teams are similar. I don't think this is something we need to change, but perhaps noted at least.

In regards to the kind of injuries reported across the country, most are during practice and have to do with backstroke collisions and slipping on deck. That's usually up to the coach/lifeguard/swimmers to avoid, but there were also a lot of injuries during dry lands. We could definitely invest in more training for coaches in this area. Using the gym equipment in a safe manner, and getting the proper instruction on how to facilitate safe dry lands. More information on the different kinds of drylands for various age groups would be relevant. I think we focus a lot on the stroke technique, and could use some more training on dry land programs that don't accidentally hurt the kids.

Discussion: Many of our teams do not report injuries to USAS. Reports of injuries that happen at Y's go to the Y's. Do Y teams need to report to USAS as well? What is the best practice? Zach Mullin will confirm with USAS.

BUDGET

MOTION by Lia Langeveld and Suzi Buccanfuso to increase support for open water LSC Championship to \$8,000 and up to \$2,000 for a team event.

Discussion: need a plan in place to support open water events – marketing, recruitment of swimmers, training, etc.

Should we have an Open Water Camp? Alex Meyer is interested in running a clinic. Several of higher level open water opportunities for swimmers (Nationals, Zones, etc) that are more attainable than higher level pool events. *Motion passes with 3 opposed.*

NOTES ON NEW USA SWIMMING BY-LAW RECOMMENDATIONS

A. USA Swimming is encouraging a reduction in the size of the Board of Directors. Over the past few years, MESI has made a reduction to the BOD so that it now stands at 16 voting members. USA Swimming has named 7 core BOD members .

- 1. 1 General Chair
- 2. 2 Administrative Vice-Chair
- 3. 3 Finance Vice-Chair
- 4. 4 Senior Vice-Chair
- 5. 5 Age Group Vice-Chair 6 Secretary

7 Treasurer

Other positions suggested:

The BOD has recommended keeping our BOD as it exists now excepting taking the non-voting position of Camp/clinic Coordinator and rolling it as a committee under the Age Group Chair and the Disability Coordinator and rolling it under D & I. The BOD also recommended that the Safe Sport Chair become an elected position instead of an appointed positon.

Moving forward, the Finance Committee, Senior Committee, Age Group Committee, Safe Sport Committee and Diversity & Inclusion Committees will become active working committees to support the Chairs. These Committees must have at least 20% athlete representation.

B. USA Swimming is requiring the establishment of a Governance Committee. They have allowed the LSCs the ability to decide if they wish to establish a separate Governance Committee or establish a Governance/Nominating Committee. Most smaller LSCs have established the joint committee and MESI has followed this protocol.

C. USA Swimming allows for 1 Senior Athlete Rep and 1 Junior Athlete Rep. the other Athlete Reps will be At-Large Athlete Board Members. They can be elected at the same time as the others. Maybe the one with the most votes becomes the Junior Athlete Rep the At-Large Athlete Rep?

D. A significant amount of language has been moved out of the Bylaws (which are controlled by the House of Delegates) and into the LSC Policies and Procedures document (which is controlled by the Board of Directors) for simplified LSC governance.

E. Group Member Representatives (i.e., Club Representatives) are no longer required to be individual members of MESI Swimming/USA Swimming.

F. Safe Sport Chair will no longer have term limits along with Secretary, Treasurer and Technical Planning.

G. Finance Committee will have one non-board member. This can be an athlete or a non-athlete. Allows for someone with a Finance background not on the Board to be part of the committee.
