  - C. 2022 Summer Plans > Meets, Open Water & Training bids are due February 1 for the summer season. Jim reached out to Tom at Colby today but no response yet. Mary Ellen has reached out several times in past few months and no response.
  - D. Site of Winter Trials & Champs The YMCA League is moving their state meet to March 5-6. Mary Ellen said she has talked to many of the USA only teams and though in principle they do not want to move the Trials meet, given the situation with COVID this year, they are not against moving Trials to March 12-13. As far as Champs, UMO or LRSC is fine we just need to have a meet (may be four full days at LRSC).
  - E. Anything else Mary Ellen reported that Brendan Hansen has postponed the clinic/meet and coach clinic due to COVID. He is rescheduling and a date should be determined soon.
