- Deadline for donations to be included on the inaugural plaque is 8/31/12.
 - The inaugural plaque is a one-time opportunity.
 - The Boosters organization will continue after the 50th Anniversary year however there will not be another opportunity to have your name on the plaque.
- All Boosters (in by 8/31/12) will also be listed by level in the Marlins Meet Program this fall and also on the website
- Monies from “Naming Rights” will first go towards needs for that that room or area and then to the general Boosters fund.
