Webmaster's Report

Illinois YMCA Swimming State Committee Meeting September 17, 2017

ILSWYMS- Database is up to date and Top 20 Times report is posted for the Long Course Season. An email went out to coaches notifying them of this and asking them to contact me with any issues they might notice and an opportunity to submit any meets they may not have. I gave to the end of the month to finalize the Top 20 list.

Accounts- Have continued working on cleaning up the accounts list and verifying correct emails. Currently 162 of the 520 accounts have email addresses that have not been verified. This number is up from the previous reports due to the fact that now all YMCA Officials as well as USAS only Officials that are affiliated with a Y team now have accounts. I am still looking for input on how to handle change in teams coaches. My thought is to give an account to all coaches that are registered with a team.

Officials- Still working with the State Officials Chair on several areas. I have been working on cleaning up the officials accounts and verifying toughs that are no longer active. All YMCA Officials now have their expiration date in the system and their accounts will be suspended 30 days after their expiration. Reminders will be sent out to the officials that are nearing their expiration. One thing that was discovered as I was verifying what we had versus the list from Y of the USA is that there was several officials that were trained that we did not have record of. It is imperative that the trainers send me a roster of their class after they close it out. Besides having this information for finding officials for meets it is very important with the Officials Chair election coming up this spring.

All level II officials have also been given e-mail accesses on the state site. This will allow them to search and contact officials from teams attending there meets to ask for help.

Invitational Meets- I will again be posting the Long Course Season on March 26th. If this needs to be sooner so teams can get there schedules together I am open to change it.



Master Meet Schedule- To date I only have one Districts meet schedule. These were due by September 15th. I will be contacting coaches of teams that hosted a meet or had attended a non-IL YMCA Swimming meet if I have not received it one week after the meet. I will be contacting the teams and reminding them when I haven't received their meet that they hosted or attended the previous weekend. This should resolve the problem of a team submitting an entire seasons worth of meets the week before the state meet. The templet has been posted on the state site.

Website- I am continuing to think about ways that would both help Teams, Coaches and Swimmers as well as to promote YMCA Swimming. I am always open to suggestions about this as well as any other topic.
