 - (a) Thanked everyone for their time and effort and thought behind it
 - (b) Worried that the event limit is still too much, possible to swim 8 times in one day.
 - (2) Chicago
 - (a) Thanked everyone for their time and effort.
 - (b) Must splash at the District Championship to swim at State clarification
 - (c) Why are we not using the technical rules for entries across the board- could be a nightmare for entry chair and it takes the power away from the coaches to make decisions.
 - (d) The high School boys are at a disadvantage to qualify to state in the 200 of strokes and the 400 IM since they are only here for 2 months.

 - (a) Ok with going forward. Interested in seeing how it goes.
 - (b) Does the qualified swim need to be the ILSWYMS database- was it voted on?

 - (a) Entry limit might be too much
 - (b) High School Boys are at a disadvantage

(a) High School boys and longer events qualifications?

Motioned- For this year only, for High School boys only, if you qualify in the 100 of the Stroke/200 IM, you may swim the 200 of the stroke/400 IM. If they do not have a qualifying time- they are entered at the Qualifying time.

Passed unanimously

(b) Do we defer the Qualifying time period to the spring meeting? Motioned- Tabled until the spring meeting.

Passed unanimously

- (c) The times will be submitted to the ILSWYMS database?

 Decided that it will be an administration rule, not a State by-law.
- (d) Must a swimmer Splash at District meet? Motioned- Swimmers do not have to splash at the district meet. No Second was made Motion fails
- (e) Event Limitations.
 - (i) Motioned- Remove entries limits and follow the USA Technical rules. Second was made.

Questions/discussion

- There meet limits on the YMCA National Meet of 4 individuals
- If we went to USA technical rules, 10 & under and 8 & under could swim every event in their age group.
- The thought was to avoid seeing the same 8 swimmers in the final heat.
- We voted on this last meeting and it was 9 to 3 to accept current limits.

Called to Vote- 4 for, 9 against. Motion failed

(ii) Motioned- To Change the entry limit for all age groups, no swimmer may swim more than four Individual events for the meet with no limit to the relays.

Questions/Discussion

- What was last year standard? For one day 3 individuals, 4 max
- Reasoning behind this proposal- swimmers will be over racing for several weeks. We would be doing the swimmers a favor by allowing them to focus one just the for events
- The thought was the meet was supposed to be swimmer/coach driven. Let the coach and swimmer decide how many events they can handle. If it really is such a issue- move the relays all to timed finals.
- Compromise at 5 total individual events

Friendly Amendment- to change it to 5 individuals. Seconded
