## (4) Chair

- a. Point of emphasis eligibility for the 'National Qualifying Meet' held Friday prior to the Area Champs. This meet does not count as a Y sanctioned meet for eligibility to swim at Y Nats. Rewording of the meet packet is in order.
  - i. Any swimmer in our area may participate in the Friday 'National Qualifying Meet', but it does not count as a YMCA sanctioned event for Y Nat eligibility. A swimmer must

participate in the YMCA IL/MO Area Champ meet series (district/area) to be eligible to participate at Y Nats as this is the only short course sanctioned event our area offers.

### (7) Officials Committee Report

a. Butterfly alternating kick. Clarification received from the USA-Swimming rules and regulations committee regarding when a butterfly kick is alternating: The following has been approved by the USA-Swimming Rules and Regulations Committee Chair (Bruce Stratton) and has been passed to the USA-Swimming National Officials Committee for potential inclusion in the situation/resolutions.

In the 100-meter butterfly during the swimmer's kick the left foot is observed moving up and down less than the right foot, but the right foot never crosses the horizontal plane of the left foot. The stroke judge calls a disqualification stating that the swimmer's feet alternated in relation to each other. Should the swimmer have been disqualified?

Recommended Resolution: The swimmer should not have been disqualified. The feet are not considered to be alternating in relation to each other unless the horizontal plane of one foot is crossed by the other.

- (11) Proposed Rule changes from the Spring meeting
  - a. Proposed rule change:
    - i. Area and district fees to be collected by the respective district chair and submitted to treasurer.
    - ii. Current:

The Area Championships' host YMCA shall remit to the Area Chairperson the sum of two hundred dollars (\$200.00) for each of the girls' and boys' Area Championships to cover expenses of the Area Committee. The District Championships' host YMCAs shall remit to the Area Chairperson the sum of fifty dollars (\$50.00) for each of the girls' and boys' District Championships to cover expenses of the Area Committee.

### iii. Proposed:

D. The district chair of the Area Championships' host YMCA shall collect from the host and remit to the Area Treasurer the sum of two hundred dollars (\$200.00) for each of the girls' and boys' Area Championships to cover expenses of the Area Committee. The District Chairs will collect from the District Championships' host YMCAs and remit to the Area Treasurer the sum of fifty dollars (\$50.00) for each of the girls' and boys' District Championships to cover expenses of the Area Committee.

## Rule change passed

- b. Proposed rule change:
  - i. Individual area qualifying times may be made at any YMCA, USA-Swimming, or high school meet during the current swim season prior to the district meet.
    - 1. Proof of these times will be required for any area swim that does not meet the area qualifying time. If a proof of time cannot be provided by with the meet entry, the qualifying time will not be accepted. Acceptable proof of times are:
      - 1. SWYMS (YMCA) database
      - 2. Signed proof of time by the meet referee.
    - 2. District participation by athletes is still required. Individual events swum at the district meet are the only individual events which may be swum at the area meet. The time swum will be the seed time for the area meet (for those athletes having a qualifying time swum outside of the district meet).

- 1. Should the athlete be disqualified for the event at the district meet, the seed time for the area meet will be the area qualifying time.
- 2. Declared false starts at the district meet must be requested by the athlete no earlier than the event prior to the DFS request.
  - Coaches may not request a DFS

## Proposal did not pass

- c. Excused scratches from the district meet may be accepted provided the following individuals sign off on the scratch:
  - i. District Meet Referee
  - ii. District Chair
  - iii. Area Chair
    - 1. A report will be provided by the area chair at the spring meeting identifying all such scratches.

## Proposal passed.

- d. Proposed rule change relating to no-shows:
  - i. A no show at a preliminary or timed final event will result in no penalty. A no show in a finals event shall result in the swimmer being ineligible for subsequent competition in the meet. This rule applies to the District/Area championship meet series.
    - 1. A no show at preliminaries does not constitute participation in the district meet for that event

# Proposal was passed as amended.

- e. Proposed rule change relating to the mailing of a hard copy of entries:
  - i. Eliminate requirement of a hard copy mailing of area meet entries.

#### Current:

A. Entry forms and fees shall be submitted to the host YMCA of the Area Championships. District Championship results must be submitted by the District Championships host YMCAs to both the Area host YMCA and the Chairperson of the Area Committee by the entry deadline. The entry deadline shall be determined by the Area Committee. An electronic entry shall be followed by hard copy confirmation no later than 48 hours after the entry deadline. Further, the meet entry fee shall be paid in full to the host team at any time prior to the conclusion of the Friday night scratch meeting.

### Proposed:

A. Entry forms and fees shall be submitted to the host YMCA of the Area Championships. District Championship results must be submitted by the District Championships host YMCAs to both the Area host YMCA and the Chairperson of the Area Committee by the entry deadline. The entry deadline shall be determined by the Area Committee. The meet packet will identify the method of meet entry confirmation with the expectation that an electronic vehicle be made available. Further, the meet entry fee shall be paid in full to the host team at any time prior to the conclusion of the Friday night scratch meeting.

- (12) New Business
  - a. Proposed Rule Changes submitted by the Northwest District:
    - 1) Area Rule 5.B. reads –

"There shall be a limit of four (4) entries per association in the Area Championships in any individual event." We would like to change this rule to read as follows: "Teams shall be allowed to have as many entries per association in the Area Championships in any individual event that met or surpass the Area Qualifying time at their respective District Championships; however, only the four fastest swimmers at the Area Championships will be scored. Call-ups will continue to ensure that

there are 16 qualifiers who can score." Scoring would be impacted in finals should more than 4 swimmers from one team make finals (the 5<sup>th</sup> and subsequent finalists would not score but would medal). 9<sup>th</sup> thru 16<sup>th</sup> places would not score, would medal, but not impact scoring.

Proposal was tabled for review at the spring meeting.

2) Area Rule 14.A states that Team Rosters are due to the Area Secretary by December 15. We would like eliminate this requirement. All meet entries would require signoff by the executive director and membership director that all swimmers meet the 90 and 30 day rules. Discussion. (If continues, change the process of roster submission to be 'platform independent' accepting comma delimited or excel format with specified headers in row 1 – not part of the rule). Is the administrative cost of this rule worth the benefit.

Proposal was tabled for review at the spring meeting.

- (13) Last chance summer champ meet recap 14 swims. There is still a need for a summer sanctioned meet and should be at a 50m facility. Any takers? Needs to be done about 2 weeks prior to Y Nats. Perhaps working with Hinsdale which Joliet runs the timing system typically the weekend after the 4<sup>th</sup> of July. Dave Hedden will follow up.

Appendix A USAS Convention Rule changes impacting YMCA

General question – how do we comply with rule 103.2.2 Teaching Racing Starts – specifically certification that swimmer has been taught racing starts?

Would make sense to incorporate in all Y meet packets:

.3 The meet announcement shall include the following statement: "Any swimmer entered in the meet must be certified by a YMCA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Prelim/Final format – if only one heat, referee no longer has discretion to swim it as a final only. However, the meet packet may specify this as a practice. Background of the rule was not to prevent a swimmer's second attempt for a cut at a prelim/final meet (turning the event for the swimmer into a timed final event).

## Re-write of rule 102 impacts

- NT swimmers (no prior time) may have an estimated time submitted (may not provide an estimated time if an official time exists). Meet host may require NT swimmers to estimate times. This is intended to allow better planning for timelines and to place swimmers appropriately.
- Place judges are no longer optional when pads/buttons are used. Timing example would indicate that anytime a pad time is not used the place judges order of finish needs to be reviewed. Suggest change in protocol to have place judges observation given to the timing table with timers sheets (an index card could be used to record the event's order of finish).
- Differences in timing levels for different qualifying times eliminated with exception for World, American and US Open Records which require automatic timing system, a backup camera system, or semi-automatic system if the automatic system fails.
- Replaced timing judge/recorder with Administrative Official/Referee (no impact)
- Added duty to the timer to report on the timing recording form if the swimmer had a late touch or missed the pad (no impact as we do this today)
- When watches are used as the primary timing system, 3 watches must be used. Impact depends. If a Y closed competition with times not going into SWYMS or SWIMS, this has no impact. However, if the times are going into either of these systems, 3 watches will be required.
- Clarification that only valid times are to be used in the determination of times for semi-automatic or watch times. For example, the administrative referee sees a pad time of 1:00.00, button times of 59.50, 59.75, and 1:02.00 the admin ref determines the 1:02.00 is an invalid time, the 2 remaining button times would be averaged. Same thing with watches. Should be no impact as I believe this is current practice.
