Current by-law:

In connection with the Area Championships, the meet host shall conduct a qualifying meet for the purpose of providing Area swimmers (12 years of age and older) an opportunity to achieve YMCA national qualifying times in events not included in the Area Championship. Such meet shall be run separate from the Area Championships on the Friday immediately preceding the Area Championships, and it shall not be a YMCA sanctioned event. The meet events, format, qualifying times, entry limitations, and entry fees shall be set each year by the Area Committee, which shall also provide officials for the meet. There will be no scoring of the meet, and no awards shall be presented. Participation in such meet shall not constitute participation in the Area Championships, and these Rules as they relate to Age Groups, Limits on Entries and Entry Changes, Qualifications for Participation in Area Championships (except 6G and H), Fees, Awards, Scoring, and Records shall not apply to such separate meet.

Proposed by-law:

In connection with the Area Championships, the meet host shall conduct a qualifying meet for the primary purpose of providing Area swimmers (12 years of age and older) an opportunity to achieve YMCA national qualifying times in events not included in the Area Championship and secondarily providing Area swimmers (12 and older) an opportunity to achieve personal times in any event. Such meet shall be run separate from the Area Championships on the Friday immediately preceding the Area Championships, and it shall not be a YMCA sanctioned event, and the timeline is not to exceed 2 hours. Should the projected timeline exceed 2 hours, events shall be limited by the host to meet a projected timeline of 2 hours or less by prioritizing those YMCA national events not swum at the Area Champs first and the remaining events at the host's discretion. The Area Committee shall provide officials for the meet. There will be no scoring of the meet, and no awards shall be presented. Participation in such meet shall not constitute participation in the Area Championships, and these Rules as they relate to Age Groups, Limits on Entries and Entry Changes, Qualifications for Participation in Area Championships (except 6G and H), Fees, Awards, Scoring, and Records shall not apply to such separate meet.

Proposal passed.

Current by-law

E. Except as provided in Rule 5C, in the Area Championships, relay team substitutions are permitted; provided that the swimmer being substituted has participated in his/her District Championships, and such participation does not cause the swimmer to have participated in more than four (4) different events throughout the swimmer's District Championships and the Area Championships combined. Any swimmer listed on a team roster that meets Area eligibility and participation rules will be accepted as an alternate.

Proposed by-law

Add as a subpart to E above:

Where a relay time cannot swim at the area meet due to incapacity of one of the relay participants and there is no other eligible swimmer, an appeal may be made by the head coach to a committee comprised of the elected area officers (chair, secretary, treasurer one of which must be a Level II official or the area committee must make such appointment), host team head coach, and the area staff designate. This committee will be empowered to waive entry limitation eligibility rules to allow the relay team to participate. Any such waivers will be reported by the Area Chair at the spring meeting.

Proposal passed

- a. Selection of 2013 Area Championship Meet host, site, and date.
 - i. Kishwaukee YMCA submitted a bid March 15-17, 2013.
- b. Any rule changes to be considered
 - i. Dave Hedden Q times proposes that Q times cannot become slower. Amendment to the bylaws in the generation of the YMCA area qualifying times. Motion tabled for the spring meeting.
 - ii. Rome Yount why can't coaches be behind the timers chairs at start end and on the turn end to talk with 8&U swimmers so long as they are not interfering with the conduct of the meet.
 - 1. Issues are noise and interference with starts
 - 2. Congestion in allowing people to move
 - 3. Interference in spectator observation
 - 4. Proposal let the meet referee / area chair handle on an exception basis. Allow movement of coaches at the ends of the pool. Common sense and courtesy are expected. This is to be covered in the coaches meeting on Friday prior to the champ meet.
 - iii. Dave Reynolds flash photography have an assigned marshal address flash issues and focus on no flash at the start when swimmers are on the block change the meet packet.
 - iv. Dave Hedden. Change the meet packet for 2012? Yes.
 - v. Northwest District voted for white over blue for officials at meets.
