State Officials Chair fall 2025 Report

Long Course State was a more resounding success than could have been anticipated given that we all tried something new with the music to have athletes walk to the blocks, which in turn really helped tighten up awards. With the help of the Admins at the meet and the meet ops awards folks, we were running not more than 4 minutes for awards, which I think in some part that having the bins there so the swimmers were not searching for their items and kept them right by awards. The swimmers really enjoyed the walkout music, even though I'm sure that Darby was pulling her hair out trying to find "Y" rated versions of music. Many athletes were very positive with many Officials wearing the Hawaiian shirts, and numerous thank you's were given to Officials by the athletes.

With that success being what it was, it wasn't without some apparent controversy; A parent felt that his team was "robbed" of what 'might' have been a 1st place award at State? (read email) Are there any coaches in here that feel like we're not providing the level of Officiating at state that the swimmers deserve? Have any of your coaches in your district complained about the quality of Officials during the season?

Something new that the Officials Committee will implement is training sheets, very similar in nature to that of Illinois Swimming, to make sure that new Officials are being mentored and shadowed in an appropriate manner that can be tracked. This will have to be rolled out to trainers, and all meet referees will need to ensure that trainees get the sheets done. Without feedback to the trainee, and what they need to work on, how can we expect a new Level I to improve? How can we expect a new Starter and Referee to get trained? This will provide a training tool to help the trainers give more structure to the trainee, and will more clearly delineate what we expect Officials to know and understand.

Pingo is planning on scheduling virtual training, and there are sporadic virtual classes popping up on LCDC with short course season right around the corner.

Mr. Williams,

I am emailing you today due to concerns I had regarding the officiating at the YMCA State meet this weekend. As someone who has read (mostly from my teacher colleagues) my



share of complaint emails, I hope that you are not already rolling your eyes as I know some people tend to do when they hear complaints. It is, of course, completely up to you how you want to react to my complaints. I hope that you will take them seriously.

My son has swam competitively since he was 6 years old, and has always been a very competitive swimmer. I counted 21 swim meets at the state level and above (including Central Zones and YMCA Nationals) that he has competed in. In those 21 meets he has never received a DQ. I am not sure how many events that is - likely somewhere in the 200's including prelims and finals. My son received 2 DQ's this weekend (and he was only able to swim on Sunday) - one DQ in the 100 back prelims and his relay team was DQ'd because my son "left too early."

My son has received a few DQ's in his swimming career (none after the age of 11). The hardest one to swallow for him was in a 100IM where his butt raised on the blocks before the horn sounded. I had it on video and was able to show him. It would have been his first state cut at the age of 9 - a tough lesson to learn - but a good one. I believe he was DQ'd one other time for not finishing on his back on the backstroke at age 11 (when that was his worst stroke). As a teacher I am all about him learning the hard way, and I don't accept excuses because, as a teacher, I hear them all the time.

He did not complain about his DQ's at YState. I am. Why? Because they were not DQ's. I have watched the 100 Back DQ several times and I have no idea what the official was seeing. He has become a pretty good backstroker - he was even able to make it to IHSA state finals as a sophomore this past year in the 200IM and 100 Back. It was an unfortunate and unwaranted DQ yesterday - but not the end of the world and would not have warranted an email from me. However, the DQ for the 200 Free Relay was egregious. I have watched the video 20 times and I just don't know what to tell him. These elite swimmers spend a lot of time on timing up their relay starts - it is a big deal. The official was flat out wrong - 100 out of 100 objective people would feel the same way after watching the video. I sincerely hope that you have officials that know the rules and are able to apply them correctly. If it were an individual event it wouldn't bother me, but 3 other kids lost a medal and, what would have been a meet record, and 4 kids have gold medals that don't deserve it. The official, or officials, that made that call shouldn't be allowed to officiate at the highest meet that the Illinois YMCA has to offer.

Lastly, and this is probably just sour grapes, but there were 4 DQ's at the Men's 21&U level. Three of those were from the same team. Do the officials at the YMCA State Meet have a team affiliation? I am guessing it wasn't the same official that DQ'd all 3 of the kids and the relay. I hope that it wasn't.

I appreciate you reading this email. I am not typically a complainer - I only remember sending one other email complaining about something sports related and that was when my youngest was being replaced by a "Courtesy Runner" when he was 10 even when he wasn't catching or pitching because he's a slow kid. I realize that there is nothing that can be done at this point - and I am not looking for anything other than you review your policies on how



you select officials for your state meet. It is very unfortunate that 4 kids were robbed of being able to say they were record holders because an official either 1. doesn't know the rules, 2. doesn't want a certain team to win or 3. just isn't paying attention.

Good afternoon Tim,
I will attempt to stick to your paragraphs to reply so as to provide the information in the areas as you've provided them to me.

During the start, there is a referee and starter that observe the starts, where the rule specifically states on the starters command "take your marks', the swimmer shall immediately assume their starting position...when all swimmers are stationary, the starter shall give the starting signal". Any swimmer initiating a start before the starting signal may be disqualified 'if' the referee independently observes and confirms the starter's observation that a violation occurred. Please note that a dual confirmation process is utilized here. No one referee, nor one starter can singly state that a false start occurred.

The process for relay take off exchanges during the 200 free relay is done in a similar manner, except that there are anywhere from 1 to 4 take-off judges observing exchanges. You will note that there were 4 used during finals, on both ends of the pool, which is the ideal situation to properly observe exchanges in a balanced way across both ends of the pool. Exchange judges, whether viewing lanes 1-5, or 6-10 are looking from the inside lane (5) towards lane 1, and the outside (1) towards lane 5. The process is that if an inside judge has an early exchange, that they will confer with the outside judge following the last swimmer departing the blocks to see if there is a match. If there is a match, then both Officials sign the bottom of their take-off cards, and initiate the process of writing up a DQ slip with the chief judge. Again, this is a dual confirmation process. In smaller meets to ensure dual confirmation, oftentimes the deck referee will whistle the race opposite the starter to observe all lanes, which is less than ideal in a championship setting, but very common at dual and tri meets. Being in the stands does not provide the visual angle required to properly observe exchanges.

The final portion I will address now; DQ's do happen in finals. Is it entirely the norm? No. But that does not mean that the Officials should observe swims with less rigor than they do prelims because these are finals. In this instance there were 3 from the same team. To address the concern of bias, there will not be any bias with any Official tolerated on a pool deck that I am on, nor would the Meet Referee, regardless of whom may be in that position. I will personally remove any Official that has any tendency of bias towards a team, or a call for a DQ.

Regarding the competency and experience of Officials, during this meet we had between Y level 1 and USA stroke and turn (the same level of Official, just different names for both) 13 Officials. These folks are the turn judges and will walk stroke on the side of the pool, and possibly observe



relay exchanges. Our next level, Level 2 in YMCA, and then the USA starter and referee, we had 16 of those folks.

The tendency at the state meets is that we generally get more experienced people, and will mix them in stroke positions, chief judge positions, in addition to starter or referee. Experience level ranged from 1 year or so at their respective position, to 5 years or greater. The referees at Saturday and Sunday finals have in excess of 5 years in that position, and the starter for Sunday has been officiating for 20 years or more. We rely very heavily on the senior referees and starters at finals as to ensure fair starts, and for the referee to be the advocate for the swimmer, which is their job to question DQ's.

And I will address the final sentence now.

- 1. I don't believe that any Official walking on a pool deck doesn't know the rules, as we go over them during the stroke briefing prior to session start, so everyone is reminded on rules and protocol.
- 2. We are to be impartial observers, and as I stated above, I will remove an Official that has a bias towards any team, or a particular call.
- 3. Lastly: Officials are told during training to act as if they are "on video". Not paying attention to the pool when you have swimmers in your jurisdiction, is not acceptable, and any Official observed not paying attention will be spoken to. There are ways to know when people are paying or not paying attention.

Again, I do appreciate you taking time to air your grievances with me, and as always, we do a lot of looking inward to ensure that we have good Officials on deck, everywhere, not just at the State Meet.



Chicago Suburban District Report
