Each district representative to the State Committee must be either a layperson qualified as a YMCA official or a YMCA employed coach. No more the than two of such four representatives may be YMCA employed coaches or YMCA Officials. In each case a lay representative must be either a current member of a YMCA located in such District or endorsed for such representative role by the Executive Director of a YMCA located in such District;
