Pool Information	The Edward T. Hall Aquatic facility features an indoor eight (8) lanes 25 yards pool, with non-turbulent lines and continuous flow through gutters.  Competition Pool:  Competition lanes  Competition lanes are a minimum of 8'wide.  Water depth is 8.6ft to 13ft.  The competition course has not been certified in accordance with 104.2.2C(4).  The meet will be swum in a 25-yard course. Lane configurations for competition will be determined upon receipt of entries. Lanes will be available for continuous warm-up/down. Facility Information	<ul> <li>All swimmers and meet personnel on deck must have credentials to be on deck.</li> <li>Locker room information: Locker rooms are located on the pool deck near the 25-yard pool area and will be clearly marked. No adults will be allowed in these locker rooms. Men's General and Women's General locker rooms are designated for Swimmers. Men's Varsity and Women's Varsity locker rooms are designated for adults/volunteers/coaches and officials.</li> <li>Restroom information: Restrooms for spectators are located in the main lobby; past the Front Desk area and right down the hallway.</li> <li>Athlete and non-athlete entrance points: Athletes and Spectators should enter the facility from the side or front entrance of the building. Coaches and Officials may enter/exit through the glass doors by the starting blocks.</li> <li>The facility will open to Athletes and Spectators 30 minutes prior to the start of warmups.</li> </ul>
Medical Assistance and Supervision	The meet venue will provide the appropriate number of certified lifeguards, AED device(s) and first aid equipment during all sessions of the meet.
Parking	Parking is authorized in designated areas only. Vehicles parked in unauthorized spaces or on the grass are subject to citation and towing.

Hospitality	There will be a hospitality area open to all coaches and officials in the breakroom on the lower level.

Rules	<ul> <li>The Meet Referee will be in charge of the meet. Any questions regarding the conduct of the meet should be made directly to the Meet Referee. The Meet Committee and/or Meet Referee may find it necessary to change some meet procedures and/or timeline to provide the best possible situations and conduct of the meet for the athletes; including, but not limited to start times, breaks, distance event procedures, weather related disruptions, etc.</li> <li>This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional, and exceptions are stated. MDSI Rules shall also apply.</li> <li>USA Swimming / MDSI Safety Guidelines and warm-up procedures will be in effect for the entire meet.</li> <li>All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of the participation in the conduct of this competition.</li> <li>Please note that the timing equipment uses a strobe as part of the starting equipment. Therefore, flash photography is PROHIBITED at the start of all the races.</li> <li>No one will be allowed on deck unless they are registered with USA Swimming as an athlete, coach or official and/or those who are part of the timing, marshal and administrative staff assisting with the conduct of the meet.</li> <li>The MDSI Scratch Rule is in effect for positive check-in events in this meet. If a swimmer fails to swim after checking in, the swimmer will be disqualified from hi/her next individual event. Swimmers failing to positively check-in will not be penalized nor allowed to compete in that event. Use of a declared false start will not eliminate this penalty.</li> <li>Swimmers entering the meet must be registered with MDSI by the entry deadline date. Per MDSI rules, any club that enters an unregistered athlete will be fined \$100.00</li></ul>

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Videotaping or picture taking on deck, by any meet volunteer, shall not be permitted. Volunteers wishing to video or photograph their swimmer shall do so from the spectator area if available. Any person(s) violating this rule will be subject to discipline by the Meet Director or Referee up to and including removal from the venue for the remainder of the meet. EXCEPTION: The MDSI Certified meet photographer and anyone else specifically given preauthorization by the Meet Director or Referee. Deck changes are prohibited. Swimmers participating in deck changing will be in violation of the USA Swimming Code of Conduct/Sportsmanship Policy and could be subject to removal from further competition in the meet. Tech Suits are banned for all 12 & Under swimmers (USA Swimming Rule 102.8.1.F). Failure to comply with any rules and/or the request of a Safety Marshall shall be considered a Code of Conduct Violation. Safety The Maryland Swimming, Inc. safety program is in effect for this meet. All USA Swimming athletes must be under the supervision of a USA Swimming member coach. Arrangements for coach supervision must be made in advance of the meet. No running or horseplay will be tolerated. Upon approval of the facility, swimmers are allowed to use only personal kickboards, pull buoys, and snorkels in non-competition warm-up areas. **Racing Starts** Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing both a forward racing start and a backstroke start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Health All meets in the Maryland Swimming LSC are guided by the Maryland Guidelines Department of Health and Mental Hygiene. This not only applies to Viral Gastroenteritis but other infectious diseases as well. The Meet Referee has the authority to inform and protect coaches, spectators, volunteers, and swimmers from a potential outbreak of illness. At the discretion of the Meet Referee, anyone who exhibits symptoms of illness may be asked to withdraw from the competition for a 24-hour period. Swimmers must be cleared, by the Meet Referee, prior to returning to competition. **Deck Access** There will be a check-in process for all coaches, officials, and approved meet staff. The check-in table will be located at the main facility entrance area. Credentials must be presented showing current fully certified USA Swimming membership. Meet staff must be listed on an approved list provided to the host team.

Volunteers	<ul> <li>Volunteers will be determined by the meet host and will be communicated to the teams attending the meet prior to meet.</li> <li>Great Mills Aquatic Club and Calvert Aquatics Club will be assisting with volunteers.</li> </ul>

Format	<ul> <li>All events will be swum as Timed Finals.</li> <li>Events will be swum slowest to fastest unless otherwise indicated.</li> <li>Events that require positive check-in: 500 Freestyle and 400 IM</li> <li>Upon request by the Meet Director, the Technical Planning Chair may split or combine sessions in order to run a more effective meet. The order of events may not be changed.</li> </ul>
Eligibility	<ul> <li>All swimmers must be registered with USA Swimming, Inc.</li> <li>Swimmers must be registered prior to the entry deadline.</li> <li>There will be no on-deck registration available at this meet.</li> <li>A swimmer's age on the first day of the meet will determine their age for the entire meet.</li> <li>There are no time standard restrictions for this meet; NT or "No Time" will be accepted.</li> </ul>
Swimmers with Disabilities	<ul> <li>CBAC welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets.</li> <li>Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Entry Director, Meet Director, and Meet Referee by the entry deadline, including the need for any personal assistants required and/or registered service animals.</li> <li>Failure to provide advance notice may limit the ability to accommodate all requests.</li> </ul>
Entry Procedures	<ul> <li>Entry deadline is Wednesday, January 10th at 11:59pm.</li> <li>No Times (NT) will be accepted.</li> <li>The conforming time standard will be SCY times.</li> <li>Non-conforming times will be accepted.</li> <li>Converted times will be accepted.</li> </ul>

	<ul> <li>A completed and signed entry summary sheet and payment in full must be received by the Meet Entry Coordinator prior to the entry deadline.</li> <li>The host team's entries shall be processed first, then entries will be processed in the order in which they were received until the timeline limit is reached. Entries thereafter shall be returned immediately.</li> <li>There will be deck entries allowed for swimmers already registered in the meet, and where availability allows.</li> <li>Maryland Swimming, Inc. entries received prior to the entry deadline receive priority over out of LSC entries.</li> </ul>
Entry Limitations	<ul> <li>Swimmers may enter a maximum of 4 individual events per session and a total of 9 individual events for the meet.</li> </ul>
Entry Verification	<ul> <li>An email will be sent to the person submitting the entries confirming receipt of the entry file within 48 hours of receipt.</li> </ul>

Seeding	<ul> <li>The conforming time standard for this meet is short course yards (SCY).</li> <li>Swimmers will be seeded and swim from slowest to fastest unless otherwise indicated.</li> <li>The 500-yard Freestyle event will be seeded and swum fastest to slowest by entry time alternating women and men.</li> <li>All non-conforming times will be seeded last.</li> </ul>
Positive Check-in	<ul> <li>Check-in will be located at the computer table and will be required for the following events.         <ul> <li>500 Freestyle</li> <li>400 IM</li> </ul> </li> <li>The MDSI Scratch Rule is in effect for positive check-in events in this meet. If a swimmer fails to swim after checking in, the swimmer will be disqualified from hi/her next individual event. Swimmers failing to positively check-in will not be penalized nor allowed to compete in that event. Use of a declared false start will not eliminate this penalty.</li> </ul>
Scoring	There will be no team or individual scores kept for this meet.
Awards	<ul><li>There will be a Heat Winner prize for every heat.</li><li>No ribbons or awards.</li></ul>
Warm-Ups	<ul> <li>The meet host will provide a complete schedule of warm-up procedures to include lane assignments and times, which must be adhered to by all participants. This information will be distributed in advance of the meet and posted throughout the venue.</li> <li>Warm-up procedures may be modified based on the number of swimmers in the meet and other safety and logistical concerns.</li> </ul>
