| Pool Information | Indoor eight-lane 50-meter pool with non-turbulent lane lines and continuous flow through gutters. <br> - Competition Pool: <br> - 850-meter lanes <br> - Competition lanes are a minimum of 8 'wide. <br> - Water depth is $4^{\prime} 0^{\prime \prime}-7^{\prime} 6^{\prime \prime}$ <br> - Warm-up Pool: <br> - 25-meter lanes <br> - Warm-up lanes are a minimum of $8^{\prime}$ wide. <br> - Water depth is $7^{\prime} 0^{\prime \prime}-7^{\prime} 6^{\prime \prime}$ <br> - The competition course has not been certified in accordance with 104.2.2C(4). <br> - The meet will be swum in a 50-meter course. | Facility Information | - All swimmers and meet personnel on deck must have credentials to be on deck. <br> - Swimmers may only use the visiting team locker rooms. They will be clearly marked, and no non-athletes will be allowed in these areas. <br> - The swimmers may not prop open the door between the two locker rooms to access the varsity locker rooms. Swimmers are not to use restrooms in the hallway. <br> - Coaches, officials, and volunteers are to use the Varsity locker rooms on the pool deck. They will be clearly marked, and no athletes will be allowed in these areas. <br> - Spectators may use the restrooms located outside the pool area. <br> - Spectators, volunteers, and athletes must enter the facility through either set of main doors. <br> - Coaches and officials may enter the facility through the doors adjacent to the pool deck. <br> - There are no folding chairs allowed in the spectator stands. <br> - Swimmers leaving the pool area are required to wear shirts, shorts or pants, and shoes at all times. |

| Rules | - The Meet Referee will be in charge of the meet. Any questions regarding the conduct of the meet should be made directly to the Meet Referee. The Meet Committee and/or Meet Referee may find it necessary to change some meet procedures and/or timeline to provide the best possible situations and conduct of the meet for the athletes; including, but not limited to start times, breaks, distance event procedures, weather related disruptions, etc. <br> - This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional, and exceptions are stated. MDSI Rules shall also apply. <br> - USA Swimming / MDSI Safety Guidelines and warm-up procedures will be in effect for the entire meet. <br> - All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of the participation in the conduct of this competition. <br> - Please note that the timing equipment uses a strobe as part of the starting equipment. Therefore, flash photography is PROHIBITED at the start of all the races. <br> - No one will be allowed on deck unless they are registered with USA Swimming as an athlete, coach or official and/or those who are part of the timing, marshal and administrative staff assisting with the conduct of the meet. <br> - The MDSI Scratch Rule is in effect for this meet. This will be a full scratch meet for both individual events and relay events as described under USA Swimming scratch rules 207.11.6, except where noted. A no-show in the preliminary or timed finals events will not incur a penalty. A no-show in finals will result in the athlete being barred from all further competition. If a swimmer in the Maryland Swimming LSC, Inc. fails to scratch from and compete in the bonus, consolation, or championship finals event and it is the |


|  | swimmer's last event of the meet, the swimmer's team is fined $\$ 50$ per the Maryland Swimming Championship Meet (MSCM) <br> - Swimmers entering the meet must be registered with MDSI by the entry deadline date. Per MDSI rules, any club that enters an unregistered athlete will be fined $\$ 100.00$ per unregistered athlete. No Deck Registrations will be permitted. <br> - Use of audio or visual recording devices, including a cell phone, are not permitted behind the starting blocks or in changing areas, rest rooms or locker rooms. <br> - Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. <br> - Videotaping or picture taking on deck, by any meet volunteer, shall not be permitted. Volunteers wishing to video or photograph their swimmer shall do so from the spectator area if available. Any person(s) violating this rule will be subject to discipline by the Meet Director or Referee up to and including removal from the venue for the remainder of the meet. EXCEPTION: The MDSI Certified meet photographer and anyone else specifically given preauthorization by the Meet Director or Referee. <br> - Deck changes are prohibited. Swimmers participating in deck changing will be in violation of the USA Swimming Code of Conduct/Sportsmanship Policy and could be subject to removal from further competition in the meet. <br> - Tech Suits are banned for all 12 \& Under swimmers (USA Swimming Rule 102.8.1.F). <br> - Failure to comply with any rules and/or the request of a Safety Marshall shall be considered a Code of Conduct Violation. |

| Safety | - The Maryland Swimming, Inc. safety program is in effect for this meet. <br> - All USA Swimming athletes must be under the supervision of a USA Swimming member coach. Arrangements for coach supervision must be made in advance of the meet. <br> - No running or horseplay will be tolerated. <br> - Upon approval of the facility, swimmers are allowed to use only personal kickboards, pull buoys, and snorkels in non-competition warm-up areas. |
| Racing Starts | - Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing both a forward racing start, and a backstroke start or must start each race from within the water. <br> - When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. |
| Health Guidelines | - All meets in the Maryland Swimming LSC are guided by the Maryland Department of Health and Mental Hygiene. This not only applies to Viral Gastroenteritis but other infectious diseases as well. The Meet Referee has the authority to inform and protect coaches, spectators, volunteers, and swimmers from a potential outbreak of illness. <br> - At the discretion of the Meet Referee, anyone who exhibits symptoms of illness may be asked to withdraw from the competition for a 24-hour period. |

| Deck Access | - There will be a check-in process for all coaches, officials, and approved meet staff. <br> - The check-in table will be located at the Meet Operations table near the start end of the pool. <br> - Credentials must be presented showing current fully certified USA Swimming membership. Meet staff must be listed on an approved list provided to the host team. <br> - No one without proper clearance may be allowed in the competition areas without approval of the meet host. |
| Officials | - There will be a need for officials. Maryland Swimming welcomes and encourages anyone willing to volunteer to contact the Meet Referee by email prior to the meet or sign in once you arrive at the meet. <br> - This is a National Certification Meet. You also must submit a Request for Evaluation by July 14, 2024. To be evaluated at an OQM you must work at least 4 sessions (including official's briefings) as an official at the meet. Not all sessions need to be in the evaluated positions. Please see the National Official Certification Summary and National Official Recertification Summary on the USA Swimming Web Page (www.usaswimming.org ). Preference for assigned positions will be given to those working the majority of the sessions. <br> - The Maryland Swimming Officials uniform policies, available at www.mdswim.org, shall apply to this meet. <br> - Official briefings will be held at the date and time listed in the Deadline and Meeting Summary. <br> - Sign-up link |
| Volunteers | - This meet is hosted by ALL TEAMS of the Maryland Swimming LSC, Inc. <br> - Any team with swimmers entered in the meet shall be required to provide workers. <br> - Each team needs to provide the name, phone number and email address of a Team Manager and a coach who will be present at the meet. This information is to be submitted via the form at the end of the Meet Announcement. <br> - The Team Manager shall be available during all sessions of the meet. <br> - Each team will be sent their worker assignments once entries have been received. Worker assignments will also be posted on the Maryland Swimming LSC, Inc. website (www.mdswim.org). <br> - Swimmers entered in the 500-yard, 1000-yard, and 1650-yard Freestyle events must provide their own counters. <br> - Swimmers entered in the 1650-yard Freestyle events must provide their own timers. |

- A no-show in the preliminary or timed finals heats will not incur a penalty. A no-show in finals will result in the athlete being barred from all further competition.
- If a swimmer in the Maryland Swimming LSC, Inc. fails to scratch from and compete in the bonus, consolation, or championship finals event and it is the swimmer's last event of the meet, the swimmer's team is fined $\$ 50$ per the Maryland Swimming Championship Meet (MSCM)
- Events will be conducted in the 10 \& under, 11-12, 13-14, 15 \& over \& Open (relays only) age groups.
- A no-show in Finals will result in the athlete being barred from all further competition. There will be no penalty for a no-show in Preliminaries or Timed Finals.
- The Meet will be conducted as a Preliminary \& Finals Meet for all age groups. Certain events will be swum as Timed Finals events.
- 13-14 and 15 \& over age-groups will have a B and A Final, in that order, with the top 16 swimmers from preliminary results after scratches swimming in finals.
- No swimmers over the age of 18 are allowed to compete in the B finals unless there are not enough swimmers to fill the $B$ final heat. The top (8) swimmers in the 15 \& over age group preliminary results, after scratches, will be seeded in the A Final regardless of age. After the scratch deadline, the next ( 8 ) fastest 18 and younger, noncollegiate, swimmers will be seeded in the B Final.
- EXCEPTION: Swimmers who were enrolled in high school for the 2023-2024 school year, but have turned 19-years-old, may compete in the $B$ final.
- 10 \& under and 11-12 age-group will have an A final with the top 8 swimmers from preliminary results after scratches swimming in finals.
- The following events will be conducted as a TIMED FINALS only.
- 15 \& over \& 13-14: 800-meter Freestyle (Wednesday), 400-meter Individual Medley (Thursday), 400-meter Freestyle (Friday), and 1500meter Freestyle (Saturday)
- 11-12: 200-meter Backstroke (Wednesday), 400-meter Individual Medley (Wednesday), 200-meter Breaststroke (Thursday), 400-meter Freestyle (Friday) and 200-meter Butterfly (Saturday)
- 10 \& Under: 400-meter Freestyle (Friday)
- For the above timed finals events, the top (8) seeded 12 \& under swimmers in each event after scratches will compete during the Finals session. The top (16) 13 \& older swimmers in the 400-meter events after scratches and the top (8) swimmers after scratches for events over 400 -meters will swim in the Finals session and will be swum slowest to fastest. The remaining swimmers will swim in the Preliminary session and shall be seeded as noted below.
- Events 5 \& 6 (11-12 200-meter Backstroke) will be swum as TIMED FINAL events slowest to fastest in event order. The fastest heat of each event will be swum during Finals Session 2. The remaining heats will be swum during Preliminary Session 1 in event order.
- Events 29 \& 30 (11-12 400-meter Individual Medley) will be swum as TIMED FINAL events fastest to slowest alternating Women \& Men. The fastest heat of each event will be swum during Finals Session 2. The remaining heats will be swum during Preliminary Session 1 alternating Women \& Men.
- Events 31 \& 32 ( 15 \& Over 800 Freestyle) and Events 33 \& 34 (13-14 800 Freestyle) will be swum as TIMED FINAL events fastest to slowest alternating Women \& Men as well as age groups. The fastest heats will be swum during Finals Session 2 in event order. The remaining heats will be swum during the Preliminary Session 1 fastest to slowest alternating Women \& Men as well as age groups.
- Events 35 \& 36 (11-12 200-meter Breaststroke) will be swum as TIMED FINAL events slowest to fastest in event order. The fastest heat of each event will be swum during Finals Session 4. The remaining heats will be swum during Preliminary Session 3 in event order.
- Events 37 \& 38 (13-14 400-meter Individual Medley) and Events 55 \& 56 (15 \& Over 400-meter Individual Medley) will be swum as TIMED FINAL events slowest to fastest in event order. The fastest (2) heats (16 swimmers) of each event will be swum during Finals Session 4. The remaining heats will be swum during Preliminary Session 3 in event order.
- Events 95 \& 96 (10 \& Under 400-meter Freestyle) and Events 97 \& 98 (11-12 400-meter Freestyle) during Preliminary Session 5 will be swum as TIMED FINAL events. The fastest heat of each event will be swum during Finals Session 6. The remaining heats will be swum during Preliminary Session 5 slowest to fastest in event order.
- Events 99 \& 100 (13-14 400-meter Freestyle) and Events 101 \& 102 ( 15 \& Over 400-meter Freestyle) will be swum as TIMED FINAL events slowest to fastest in event order. The fastest (2) heats (16 swimmers) of each event will be swum during Finals Session 4. The remaining heats will be swum during Preliminary Session 3 in event order.
- Events 111 \& 112 (11-12 200-meter Butterfly) will be swum as TIMED FINAL events slowest to fastest in event order. The fastest heat of each event will be swum during Finals Session 9. The remaining heats will be swum during Preliminary Session 7 in event order.
- Events 133 \& 134 (15 \& Over 1500-meter Freestyle) and Events 135 \& 136 (13-14 1500-meter Freestyle) will be swum as TIMED FINAL events. The fastest heat of each event will be swum during Finals Session 8. The remaining heats will be swum at the end of Preliminary Session 7, fastest to slowest alternating Women \& Men as well as events.
- All Relay events will swim in the Finals sessions.
- BREAKS: After entries are received, breaks between events may be applied to ensure swimmers receive a minimum of 20 minutes between events. These breaks will be applied at the discretion of the Meet Referee.

| Eligibility | - All swimmers must be registered with USA Swimming, Inc. <br> - Swimmers must be registered prior to the entry deadline. <br> - There will be no on-deck registration available at this meet. <br> - A swimmer's age on the first day of the meet will determine their age for the entire meet. <br> - The 2024 Speedo Maryland Long Course Championship shall be open to ALL 2024 USA Swimming Inc. / Maryland Swimming LSC, Inc. registered swimmers from registered Maryland Swimming LSC, Inc. teams and unattached Maryland Swimming LSC, Inc. registered swimmers ONLY who meet the listed qualifying times. <br> - The meet is closed to ALL swimmers and teams outside of Maryland Swimming, Inc. <br> - Swimmers entering the meet must be registered with Maryland Swimming LSC, Inc. and USA Swimming by the meet entry deadline, except for unattached swimmers who must have been a member of Maryland Swimming LSC, Inc. for 6 months prior to the meet entry deadline. <br> - A swimmer's age on Wednesday July 31, 2024 will determine their age for the duration of the meet <br> - Swimmers must be equal to or faster than the Qualifying Times established for the meet. Qualifying times must have been achieved in a USA Swimming sanctioned, approved, or observed meet, between April 1, 2023 and the entry deadline for this meet (July 17, 2024). No times achieved outside of this time period may be used to qualify for this meet. Qualifying times must have been achieved in a long course meter (LCM) pool. Converted times will not be accepted. <br> - Swimmers who qualify for an event and swim that event at the 2024 Speedo Maryland Long Course Championship Meet may not enter the same event at the 2024 Maryland Junior Long Course Championship Meet. <br> - Relays: The entry times may either be determined by an actual relay time within the qualifying period or by aggregate time. If the time is entered using an actual time swam in a sanctioned meet, the swimmers actually swimming the event in the meet do not have to be the same swimmers who swam the qualifying time. Times used to prove aggregate times must be times from swimmers who are eligible for the meet in the age group whose relay time is being proved by aggregate times. Swimmers who actually swim the relay in the meet do not have to be the same. Relay times are associated with the club, not the actual swimmers. <br> - Qualifying times exception 1: If a swimmer qualifies for either the 800-meter Freestyle event or the 1500-meter Freestyle event they may enter the other (800-meter Freestyle or 1500-meter Freestyle) event if they have not achieved the qualifying time for the event within the qualifying period. The time entered for that event should be at the qualifying time if never swum or a verifiable time outside of the qualifying period if swum before. The |

| Swimmers with Disabilities | - Maryland Swimming welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. <br> - Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the Meet Entry Director, Meet Director, and Meet Referee by the entry deadline, including the need for any personal assistants required and/or registered service animals. <br> - Failure to provide advance notice may limit the ability to accommodate all requests. |
| Entry <br> Procedures | - Wednesday, July 17,2024 , at 8:00 pm. <br> - No Times (NT) will not be accepted. <br> - The conforming time standard will be LCM times. <br> - Non-conforming times will not be accepted. <br> - Converted times will not be accepted. <br> - No late entries will be accepted. <br> - No individual or relay event deck entries will be accepted. <br> - A completed and signed entry summary sheet and payment in full must be received by the Meet Entry Coordinator and Meet Director prior to the entry deadline. <br> - Submissions must also include an entry fee report and team entry report with proof of times for both individual and relay event entries. <br> - Relay-only swimmers must be included on your roster. This can be done by adding names to your Relay entries (including alternates). Those names can be changed up until the time of the event. No swimmers can be added to your roster after the deadline of the meet. <br> - Relay-only swimmers will not be charged the Athlete Surcharge if they do not swim in the event. <br> - Bonus events should be marked with a "B" OR AN *. |
| Entry <br> Limitations | - Swimmers 12 \& under may enter a maximum of 3 individual events per day and a total of 9 individual events for the meet. <br> - Swimmers 13 \& over may enter a maximum of 3 individual events per day and a total of 8 individual events for the meet. <br> - Swimmers may enter a maximum of 1 relay per day. Swimmers may enter a maximum of 2 relays for the meet. <br> - The Meet Entry Director reserves the right to limit entries to ensure that sessions fall within the Maryland Swimming LSC, Inc. rules. If the meet becomes oversubscribed, the meet will be reduced in the following order: <br> - Bonus events will be eliminated. Individual events shall be limited to (8) or (7) per swimmer. Converted times will not be accepted. <br> - Bonus events will be offered using the following guidelines: <br> - Qualify for 1 event, may have up to 5 bonus swims. <br> - Qualify for 2 events, may have up to 4 bonus swims. <br> - Qualify for 3 events, may have up to 3 bonus swims. <br> - Qualify for 4 events, may have up to 2 bonus swims. <br> - Qualify for 5 events, may have up to 1 bonus swim. <br> - Qualify for 6 or more events, no bonus swims. <br> - The bonus events may be used on any day of the meet. <br> - Entry times for bonus swims shall be the 2021-2024 USA Motivational Time Standards BB standard or faster for the age group. <br> - Events 400-meters or longer are not eligible as bonus events. (400-meter Individual Medley, 400-meter, 800-meter, and 1500-meter Freestyle). <br> - If the meet becomes oversubscribed, the bonus events will be the first entries removed from the meet. |
| Entry Verification | - An email will be sent to the person submitting the entries confirming receipt of the entry file within 48 hours of receipt. Please contact the Meet Director if an acknowledgement has not been received. |
| Proof of Times | - Must be submitted with the entry file to the Meet Entry Coordinator and the Meet Director. <br> - A times recon will be run prior to the meet to ensure swimmers are within the qualifying times for the meet. |
