OLD Business

<u>BOR Proposal</u>: (Bouchey) Motion to add \$150 filing fee for Board of Review filings. Motion Fails

<u>Championship Meet Formats:</u> (McBratnie) The Technical Planning Committee put forth proposals for District and Junior Olympic Championship Meets for the 2013-2014 SC Season. Much discussion ensued regarding the format of these meets, the event offerings at these meets, and age group offerings at these meets. Through vast conversation, it was decided to host:

Four (4) District Championship Meets, with Saturday/Sunday am and pm formats, Age Groups being 10/U, 11/12, 13/14, 15-18. Event options shall be full range, including 200's for those age groups where 200's are offered at LSC Championships.

Three (3) Junior Olympics Championship Meets, 3 day Format (Friday/Sat/Sun), 5 sessions, 10 entries (2 Fri, 3 Individual+1relay Sat/Sun) Events to include 1650 as that

allows qualification in 1000 down based on splits times, 200's for those offered in LSC Championship meets.

<u>2014 MI Swimming Championship Standards:</u> (McBratnie) Joe presented updated qualifying times based on an expanded algorithm including 6 years of past data. The process was discussed, and the standards presented were agreed upon and accepted.

Emergency Meet Sanctions: not discussed

Long Course '14 Skeleton Meet Schedule: not discussed

<u>New MI Swimming Membership Cards for Non-Athletes:</u> (Wilkins) Jeff presented an example of a new USA/MI Swim non-athlete membership card. Example from AZ Swimming. Will have double sided printing with current membership card on one side and a photo ID for MI Swimming on the other. Ordering printer to be able to produce cards from MI Swim office. Will require submission of Passport photo. Expense of aprox \$3500: motion Bouchey, second McBratnie. Motion carries

<u>Appointment of Administrative Vice-Chair:</u> (Wilkins) Jeff announced the appointment of Katy Dean (CUDA) to the Admin VC position as permitted by the MI Swim By-Laws under the position of General Chair. This appointment will fill the remaining term vacated by Steve Potter until the 2014 MI Swimming House of Delegates Meeting.
