OLD Business

•Championship Meets: (Robertson) JO's 3 sites secured and awarded (EGRA, CSW, KAW) Districts set to go with 4 hosts(PAC/LAC, HVP, CSW, MCA). Meet packets in the works, being written on 1/6, expected to distribute by end of week.

•Championship Meet Officials Discussion (Perczak/Wilkins)Districts and JO are serving as training and meet referees will be assigned by MI Swimming Officials Committee. Club officials will have priority for host clubs. Robertson mentions hotel costs as a consideration, Perczak assures locality will be part of process.

"Divisions" tab to be editable for each individual division of MI Swim. Each chair, committee, or Board Member can edit their respective pages. The board reviews example pages. Need to figure out how to protect Athlete Rep emails from public view, but have a way to allow members to contact them.

Program Operations – Damon Robertson: Champ Meets addressed in Old Business. Will order awards, has the event lineups complete for SC14 Champ Meets. Will get LC14 skeleton schedule out this week. "Quad Meet Recap" (title??zone??) Meet was reformatted due to incoming weather, condensed format allowed families to get home safely. Likely had negative impact on athletes performance. Two meet records broken by Team MI. Colin Dolcetti, Joe McBratnie, Damon Roberston, and Dave Carson served as coaches for 66 swimmers representing the LSC.

h.Diversity – Geneen Bradley: Working on Diversity camp with east and west side of the state alternating. Aiming for April. USA Swimming to send representation.

Michigan Swim Office

a. Registration / Membership / Athlete Records / Clubs – Jan Cartmill: 7,807 athletes registered, 500 non-athletes, 82 Clubs. Registration has been hectic in end of December, everyone waiting til last minute. Jan asks about R&P Reviews, needs addressing. By-Laws submitted to USA Swim legal. Discussion regarding new website launch, database in the TU format, managing multiple websites during transition and building of new site.

b.Sanctions/Results/Times/TSO John Loria: Meet results current. Has continual trouble with meet sanctions and packets coming in late, looking for guidance from board about how to handle late submissions. Do late submissions go to front of queue? Or, work in order received? Board decides that Mr. Loria should work in order received.

Discussion about District/JO packets: Damon will furnish MM Files and Locked Invitation Template to host teams.

(Bouchey) What is the status of the locked meet information packet template that is only editable in certain sections making the review of packets more efficient? (McBratnie) Joe had developed this formatted packet and sent to John Loria for review. Loria plans to have ready for LC season.

(Robertson) What is the status of AO Clinic scheduling? Jan 4th meeting did not occur? Perczak to take question to Officials Committee.
