Coach Grant Report

Email from Grant:

-Coach updates: the spring session has been going well. We have 30 swimmers total, which I consider good considering we did not have a spring session last year. With the Seniors, we have been doing very detailed stroke technique work as we ease back into training. I am also trying to keep them mentally stimulated by having new workout formats.

Regarding the rest of our coaching staff, we again have high turnover as many of our coaches are leaving the area. Coach Emily's last day is May 2nd as she is transferring to Ithaca College to finish her masters degree. Coach Martin's last day is May 5th as he is now graduated. All other coaches are out of town for the summer. Anna Karubas and Jef Leroux are both NMU swimmers who will be coaching this spring.

I have submitted both of our meet bids for the 2026-2027 short course season.

- -Kentucky trip: it is my opinion we should at least be able to fill one minivan to continue trip planning. I understand that for many the timing does not work or the trip is too expensive. It is still my goal to find unique experiences for our athletes that will get them even more excited about swimming and provide them swimming opportunities beyond the U.P. and northern Wisconsin. I am open to suggestions as to how to accomplish this.
- -Swim lessons: lead contact me or Chad. To avoid conflict of interest, Heidi cannot be involved. Swim lessons would not be affiliated with NMU in any way and we would only have them at MSHS. Once I return from my trip I will be emailing Jackson with a detailed plan to see if we can negotiate a pool rate less than \$60/hr. (may instead just be 30% of revenue generated—this is common and makes them interested in our success as more kids involved = more money for them too). Instructors will be paid at least \$15/hr. Effective 1/1/2027 that will be minimum wage in Michigan so it doesn't really make sense to pay less than that at this point. For registration I will have to check if there is a way we could set this up on our team website, but not sure if that is possible. More details to come.

-August block party: I am able to make the meet file for this meet too. Event list is TBD. For previous block parties I have asked the kids what events they want to swim, so I can do the same again in MQT and Laura could ask the kids in Houghton. Perhaps we release the event list sometime in the July 13-18 week to give two weeks to plan?

Discussion of best option for WAC

In order for us to pay Grant and then complete the taxes, we could do the following:

- Grant could complete a 1099 form which can be found online and the instructions for submitting to the IRS can be done online
- A 1099 is easy for a non-profit because then we don't have to pay taxes and Grant would claim the income on his tax return. By doing a 1099, it avoids us from withholding any taxes and Grant would then submit them to the IRS. However, Grant would need to ensure he is aware of his taxes throughout the year because it would then be claimed at the end of the year.
- She believes it would be pretty straightforward to complete online. Since it would be for 2025, we could pay Grant for the meets throughout the year. Then by January 31, 2026, we would give Grant a 1099 to complete and submit to the IRS that has the totals of the amount paid to the coach.
- If we go the W-2 route, we would need to withhold taxes. If we do that, we could have the accountant Chad spoke to complete (thinks it would take less than 30 minutes each time Grant gets paid) and submit to the IRS quarterly.
- Chad will talk with his contact about this information as well. His contact would charge each month (?) to do the taxes, payroll. What is that cost? There needs to be a total of \$1,000 before taxes can be assessed (?)
- Overall the board felt that the 1099 could be a viable option as we are paying for a limited small amount over the year for meets (since NMU is the employer for training camps).
