- TAW - Total score if all judges agreed with Judge n. Award multiplied by 3, multiplied by Degree of Difficulty.
- RNK - Rank diver achieved using Judge n's scores only.
- DEV - Points deviation between Judge n's total and the panel's total.
- H/L - # of times Judge n was the lone high score or the lone low score.

SUMMARY TERMS

- TRD - Total of rank deviations.
- PAP - Points above the panel.
- PBP - Points below the panel.

PAC - Panel average correlation. Computed as follows: The difference between each judges award and the average of the non-deleted awards is calculated. If the difference is between 0 and 0.25 then 3 points are added. If the difference is between 0.26 and 0.50 then 2 points are added. If the difference is between 0.51 and 1.00 then 1 point is added. If the difference is greater than 1.00 then no points are added. The total points are then divided by the number of dives to determine an average.
