- 1. Meeting called to order.

- 3. Approval of minutes
  - a. Motion and second to approve past minutes for meeting on 9/10/2019. All in favor.

- 4. Vice President's Report

- 8. Meet Chair's Report

- 9. Fundraising Chair's Report
