The meeting was called to order at 6:33pm by President Chris Burlingame.

Brandon suggested several additions and possible enhancements: off-site storage (\$56/month with controlled heat), popcorn machine, hot dog roller, coffee thermos and volunteer t-shirts. Needed crockpots and roasters were offered. Hospitality Lead, Tim, is prepared and will serve Tacos Saturday and Turkey Dinner Sunday. Dion reported that to date 272 swimmers from 8 teams are registered for the meet with fees adding to \$11,284. Warm-ups begin at 7:20 both days. Saturday events run 8:30-11am & 12-4pm. Sunday events run 8:30-10:35am & 11:35am-2:30pm. All volunteer positions are filled. Becky will help Meet Manager Software volunteers.

**January 6-7 Meet Information** has been sent to MSI after renewing the club charter.

**Butter Braid Fundraiser Forms** will be passed out to swimmers and need to be returned by December 5 with delivery on December 12.
