Brandon moved to approve the **April meeting minutes**. Motion seconded and passed.

#### Old Business

Mom, dad & gray **team apparel** did not sell as well as we would have liked during the swim meet. In regard to the mock-up sweatshirt, if our order in the fall is over 30, we'll be refunded the cost of the mock-up (\$26). We'd like to see a picture mock-up with the proper purple color at the next board meeting. At the July meet we'd like to offer a special order of select items.

**Business sponsors** will have their logo on social media, our website, announce them during meets and possibly printed programs. Michael would like two parent volunteers to help ask area businesses for sponsorships.

### **Meet adjustments:**

- Brandon is to be signing volunteers in digitally (no paper!) at all meets, not doing other tasks.
- No volunteer credit to the Rischs because they did not fulfill the duties asked of them.
- We may consider a Colorado 'shadow' position at each meet. (Have one person who knows the system responsible for working it, but then have another parent volunteer shadow with them to learn the system. This will provide more people with the knowledge to run the scoreboard.)
- Could we get a TV posted in the cafeteria area showing the scoreboard?
- Add the requirement to wear our volunteer shirt to the meet sign-up.
- There were some chaotic situations during the meet, as the head timer didn't have full control of the meet. Timer meeting was missing some key information and not as professional as we are accustomed. Teresa will send a message to Bill regarding her experience during the timer meeting.
- It was a great idea to move single event seating to the middle rows. Much easier for people to get in and out.
- All volunteers will be offered water; not snacks or meals.
- Have a floater who can give timers breaks.
- The vendor Jo Lyn was giving the club credit for all sales at the meet; though many swimmers were trying on suits to know what size they should purchase online. At future meets we need to ensure our families know that the club receives this credit, so it's preferred that they purchase at the meet to support the club.
- During the months that we have a home swim meet, should that month's Board meeting be the Monday before the meet? We will discuss the date change at the Board meeting the month prior and agree upon the date change.

## **New Business**

**Banquet** date was set: Thursday, July 18. A committee of parents volunteered to coordinate: Tracy Roller, Lisa Nutter, Leslie Buggi, Jami Roberts and Erin Haugen (lead). Becky will be the Board liason with the group.
