ENTRIES: Swimmers may enter 4 Individual events per session, NT's Are NOT Accepted

**DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams

entries must be received by July 28, 2011.

2: The final entry deadline for this meet is July 29, 2011

3: Metro entries received between July 28, 2011 and July 30, 201 and all entries from

other LSC's will be entered in the order they were received, as space allows.

An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days of your original email.

**ENTRY FEE:** An entry fee of \$4.00 per individual event must accompany the entries.

Payment must be received with the entries one week before the meet.

Failure to pay entry fees by this deadline could result in teams being barred from the

meet.

WARM-UP: General Warm up in effect. Sprint lanes will be available 10 minutes prior to the

end of warm up. Lanes 1 & 10 will remain General warm up during sprints.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are

due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches and which swimmers will not be participating

in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display

current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the

deck area.

**AWARDS:** Ribbons 1<sub>st</sub>—8<sub>th</sub> place in all age groups. Heat Winner Prizes for 12&Undere Events.

All awards will be given only to a coach or team representative at the end of the meet. .

**RULES:** The current USA Swimming Rules and Regulations will apply.

The USA Swimming Code of Conduct is in effect for the duration of the meet.

The overhead start procedure may be used at the discretion of the meet Referee.

The meet announcement shall include the following statement: "Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present

throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to

follow the safety rules.
