**ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on July 8, 2011 will determine age for the entire meet.

Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special DISABILITY SWIMMERS:

**ENTRIES:** Limit of 3 events per session. Meet will be run using Hy-Tek's Meet Manager. All entries must be in

meters; NT's will not be accepted. All entries must be sent in Team Manager format

All entries will be accepted on a first come/first served basis (per below). If cuts are required they will be

done based on entry time.

Time Trials will be accepted on Sunday July 10<sup>th</sup> – 30 minutes prior to regular meet ending. Entries will

be \$5 per event – cash only at time of entry.

**DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be received by June 17, 2011.

2: The final entry deadline for this meet is June 24, 2011 or after the meet fills to capacity.

3: Metro entries received between June 17, 2011 and June 24, 2011 and all entries from other LSC's will

be entered in the order they were received, as space allows.

An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you

do not receive such a report within 2 days of your original email.

An entry fee of \$4 per individual event must accompany the entries. **ENTRY FEE:**

Payment must be received by June 24, 2011 for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

Entries for Time Trial events will be \$5 per event – cash only on Sunday at time of entry.

WARM-UP: Warm-up will follow the adopted Metropolitan Swimming Procedure. Assigned lanes. **SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

**AWARDS:** Medals  $1^{st} - 3^{rd}$ , Ribbons  $4^{th} - 8^{th}$  for individual events.

RULES: The current USA Swimming Rules and Regulations will apply. The USA Swimming Code of Conduct is

in effect for the duration of the meet. The overhead start procedure may be used at the discretion of

the meet Referee.

**SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout

warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee,

any swimmer, coach, club, or spectator for failure to follow the safety rules.

"Any swimmer entered in the meet must be certified by a USA Swimming member coach as being

proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's

legal guardian, to ensure compliance with this requirement"

The Diving pool will be closed – NO DIVING ALLOWED.

**WATER DEPTH:** Depth at diving block wall is 5.5 ft. Depth at shallow end wall is 4.5 ft.

**DISCLAIMER:** It is understood that USA Swimming, Inc. Metropolitan Swimming, Inc., the Sachem Swim Club, and the

Holtsville Ecology Center shall be free from any liabilities or claims for damages arising by reason of

injuries, to anyone during the conduct of the event.

**ADMISSION:** \$5 per adult - \$3 for session program. Seating will be available but is limited. It is recommended that

you bring folding chairs.

NO SMOKING anywhere in the pool complex.
