SANCTION: Held under the sanction of USA Swimming/Metropolitan Swimming, Inc.

LOCATION: Sachem North High School Pool

FACILITY: Colorado Electronic Timing System and 6-lane electronic scoreboard. 25 yards, 6 lane Pool

The pool has been certified in accordance with Article 104.2.2C (4)

SESSIONS: Session 1- 5:00 pm Warm-up 6:00 pm Start – November 5 -- Age groups: 12 & under, 13-18

Session 2 – 7:00 am Warm-up 8:00 am Start – November 6 -- Age groups : 11-12, 13-14

Session 3 – 1:00 pm Warm-up 2:00 pm Start – November 6 -- Age groups : 8 & under, 9-10,15-18

FORMAT: All events are timed finals. Slow to fast standard Pre-Seed Seeding. Metropolitan Association scratch

rules will be in effect for this meet.

ELIGIBILITY: Open to all registered USA Swimming swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on November 5, 2010 will determine age for the entire meet.

DISABILITY Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of

any disability prior to the competition.

ENTRIES: Limit of 3 events per session. Meet will be run using Hy-Tek's Meet Manager. All entries must be in

yards; NT's will not be accepted. Individual events are \$3. All entries must be sent in Team Manager

format.

DEADLINE: 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be

received by October 15, 2010.

2: The final entry deadline for this meet is October 22, 2010 or after the meet fills to capacity.

3: Metro entries received after October 15, 2010 and all entries from other LSC's will be entered in the

order they were received, as space allows.

An email confirming receipt of entries will be sent if you provide an email contact. Please contact the

Meet Director if you do not receive such a report within 2 days of your original email.

ENTRY FEE: An entry fee of \$3 per individual event must accompany the entries.

Make check payable to: Sachem Swim Club.

Payment must be received by November 1, 2010 for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: Warm-up will follow the adopted Metropolitan Swimming Procedure. Assigned lanes.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

AWARDS: Medals $1^{st} - 3^{rd}$, Ribbons $4^{th} - 6^{th}$ for individual events.

Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
