LOCATION: Asphalt Green AquaCenter—York Ave. & 91st Street

**FACILITY:** One 8 One 8 lane 25-yard course with 6ft. 7in. as minimum depth.

> A 20 yard lane will be provided for continuous warm up/warm down. The pool has **not** been certified in accordance with Article 104.2.2C (4)

**FORMAT:** All events are timed finals. Deck seeding will be used.

**ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on November 25th, 2011 will determine age for the entire meet.

DISABILITY SWIMMERS: Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special

consideration.

The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability

prior to the competition.

**ENTRIES:** 

Please check the signature waiver box if sending by express mail.

**DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be

received by November 10, 2011.

2: The final entry deadline for this meet is **November 17, 2011** 

3: Metro entries received between November 10, 2011 and November 17, 2011 and all entries

from other LSC's will be entered in the order they were received, as space allows.

An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if

you do not receive such a report within 2 days of your original email.

**ENTRY FEE:** An entry fee of \$3.00 per individual event must accompany the entries.

Payment must be received by November 17 for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: **General Warm-Up** 

**SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

Ribbons: 1<sup>st</sup>-8<sup>th</sup> place in all age groups. Separate awards for the 10 & Under and 11-12 Age groups in the 400 IM AWARDS:

and the 500 Free. Separate awards for the 13-14 and 15 and Over in the 400 IM. All awards will be given only to a

coach or team representative at the end of the meet. No individual awards will be given out. Awards will not be

mailed or forwarded, except in the case of computer failure.

The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee.

**SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout

warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee,

any swimmer, coach, club, or spectator for failure to follow the safety rules.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement
