ENTRIES:

Swimmers are limited to 4 events per session. All sessions MAY be limited to 3 hours before scratches. Saturday' session for 8-Under will be limited to 150 swimmers.

Sunday: 9 & Over sessions: First 35 minutes will be general warm-up. Last 20 minutes:

2 or more lanes will be open for one-way sprint. All other lanes will remain open for general warm-up.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30

minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches

and which swimmers will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, 2013

valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who

do not possess these credentials will be required to leave the deck area.
