ELIGIBILITY: Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on June 20, 2015 will determine age for the entire meet.

DISABILITY

AUDIO/VISUAL STATEMENT:

Use of Audio or visual recording devices, including a cell phone, is not permitted in changing

locker rooms or other designated areas is not appropriate and is prohibited.

ENTRIES: All Athletes are limited to enter 3 events per session.

ENTRY FEE: An entry fee of \$5.00 per individual event must accompany the entries.

Payment must be received by **June 20, 2015** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes

will be available for the remaining 10 minutes. Lane assignments will be distributed along with

the scratch sheet each session.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to draw a line through an individual event to indicate clearly that individual event is a scratch or when an athlete is out of the session completely draw a line through the swimmers name who will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

AWARDS: 1st - 10th place awards will be given to the 12&U athletes. Events 21 & 22 will be awarded for 1st-

10th for both 10&U and 11-12. Both 9-10 and 8&U awards will be given in the 10&U events. 1st-3rd

place awards will be given to the OPEN SWIMMERS.
