Athletes, parents and children are restricted to the pool area and spectators stands and are not authorized to be in any other part of the building. Offenders will be ejected

from the facility.

**ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on **Nov 8, 2014** will determine age for the entire meet.

DISABILITY SWIMMERS:

Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of

any disability prior to the competition.

ENTRIES: Swimmers may enter 4 Individual events and 1 Relay per session,

Entries are accepted on a first come, first served basis. Entries received after the entry deadline will only be accepted if the meet is not full. Deck Entries are NOT permitted. All Entries <u>must</u> be sent as a Hy-Tek file. Manual Entries <u>will NOT</u> be accepted. Mail payment along with Hy-Tek Meet

**DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be received by **Oct 24, 2014**.

2: The final entry deadline for this meet is Oct 27, 2014

3: Entries from other LSC's and Metro entries received after Oct 24 will be entered in the order they were

received, as space allows.

An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you

do not receive such a report within 2 days of your original email.

**ENTRY FEE:** An entry fee of \$4.00 per individual event, \$16.00 for relays must accompany the entries.

Make check payable to: Patriot Aquatics.

Payment must be received by **Oct 27**, **2014** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: General Warm up in effect. Sprint lanes will be available 20 minutes prior to the end of each

warm up. Lanes 1 & 6 will remain General warm up during sprints.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

rooms or other designated areas is not appropriate and is strongly discouraged
