minutes. Lane assignments will be distributed along with the scratch sheet for each session. Coaches

are responsible for enforcing feet first entry during warmup.

Deck changing are prohibited. DECK:

Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 **SCRATCHES:** 

minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA

Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.

Make a left onto route 94 and approximately 1/4 mile on the right is the entrance to the high school )you will pass the middle school first. The 2nd driveway after the middle school is the entrance). make a right into the driveway and drive straight back and up the hill
