**ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet. No "Deck

Registrations" will be accepted

Age on 1/27/2017 will determine age for the entire meet.

#### **DISABILITY SWIMMERS:**

Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.

#### **ENTRIES:**

Swimmers who swim only in the midday sessions on Saturday and Sunday (all 10 & unders timed final events) may swim a maximum of 5 individual events and 1 Relay per day. Swimmers in all other sessions may swim a maximum of 3 individual events per day (prelims and finals)

The meet will be deck seeded. 500 and 1650 will be seeded fastest to slowest alternating female/male. Slowest heat of male and female events may be combined

### **ENTRY FEE:**

### WARM-UP:

Warm up lanes may be assigned. Sprint lanes will be available 20 minutes prior to the end of each warm up. Lanes 1 & 8 will remain General warm up during sprints.

### Time Trials-

Time Trials may be held for swimmers trying to qualify for Speedo Championships (sectionals) Senior cut times or faster, AD and/or Metro Championships. Each Time trial is \$10.00. Coaches must request a time trial From the meet referee and meet director and they will determine when the Time trial will be conducted. The meet referee and meet director reserve the Right to refuse time trials longer than 200 yards.

### **COACHES:**

In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

**AWARDS:** For all individual events, awards will be for 1st - 8th place, 1-3 for relays.
