LOCATION: Nassau County Aquatic Center

Eisenhower Park, East Meadow, NY 11554

FACILITY: 10 Lane by 50 meter competition pool w/2 meter min depth

The pool Has Not been certified in accordance with Article 104.2.2C (4)

SESSIONS: Session One – All Age Groups –warm-up 5pm Start 6pm

**FORMAT:** The meet is a Timed Final Event

The meet will be Deck Seeded

**ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on July 12, 2017 will determine age for the entire meet.

**ENTRIES:** All Athletes are limited to enter 3 events per session.

Deck entries will not be accepted.

NT's will not be accepted Entries are by invite only.

Hy-Tek Email entries will be accepted

DEADLINE: Entries must be received by: June 20, 2017 Meet will fill upon a first come / first serve basis

**ENTRY FEE:** An entry fee of \$7.00 per individual event must accompany the entries. There is a \$5.00 athlete surcharge.

Make check payable to: Long Island Swimming

Payment must be received by July 12, 2017 for email entries. Payment must be included with all mail entries.

Failure to pay entry fees by this deadline could result in teams being barred from the meet.

**WARM-UP:** General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes will be available for

the remaining 10 minutes. Lane assignments will be distributed along with the scratch sheet each session.

**SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 minutes

prior to the start of the session. Coaches are asked to draw a line through an individual event to indicate clearly that individual event is a scratch or when an athlete is out of the session completely draw a line through the

swimmers name who will not be participating in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA

Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess

these credentials will be required to leave the deck area.

AWARDS: 1st – 10th place awards will be given to the 12&U athletes. Events 1 & 2 will be awarded for 1st-10th for both

10&U and 11-12. Both 9-10 and 8&U awards will be given in the 10&U events.

AUDIO/VISUAL **STATEMENT:** 

Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, behind the starting blocks or locker rooms

"Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools,

athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials

and/or spectators are present."

**POLICY:** Any photographer or videographer, who intends to take pictures at a Metropolitan Swimming sanctioned meet,

must complete and submit a Photographer Registration Form to the Meet Director before commencing activity.

Forms are available on the Metropolitan Swimming website as well as from the Meet Director.

The current USA Swimming Rules and Regulations will apply. **RULES:** 

The USA Swimming Code of Conduct is in effect for the duration of the meet.

The overhead start procedure may be used at the discretion of the meet Referee.

**SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and

> competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. "Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's

legal guardian to ensure compliance with this requirement.

**MEET** 

Each club is requested to handle its own team and discipline problems. Anyone found vandalizing county **DECORUM:** property; stealing or displacing disorderly conduct will be subject to disqualification, ejection from the meet and

possible criminal prosecution.

> Follow signs to Belt Parkway/Long Island East. Take Belt Parkway eastbound past Kennedy Airport after Kennedy Airport stay in the left lane and look for signs to Southern State Parkway East. Take So.State Pkwy East to Meadowbrook Pkwy (northbound) to NY-24 Hempstead Turnpike (exit M4) East. On Hempstead Turnpike go to the left lane and make a left at the first light (Merrick Ave.) At first traffic light make a right.

This is the entrance to the pool.
