- SANCTION:** Held under the sanction of USA Swimming/Metropolitan Swimming, Inc., Sanction # **191200**
- LOCATION:** **Bard College Pool, Stevenson Gym, Bard College, Annandale-on-Hudson NY 12504**
- FACILITY:** **25 yard pool with six 7-foot lanes; non-turbulent lane lines; seating for 150 is available; Colorado electronic timing system and scoreboard**
The pool **Has Not** been certified in accordance with Article 104.2.2C (4)
- SESSIONS:** **1650: Warm-ups at 7:30am - Meet starts at 8:00am - 3 fastest heats of 1650 -positive check-in Saturday at noon! Swimmers and coaches will be notified Saturday about the seeding of the 1650s. Please leave your cell phone so we can contact you.**
- 400 IM, 500 Free: Warm-ups at the conclusion of the 1650, approx. 9:00am - Meet starts 30 min. later, approx at 9:30am, additional 1650s will be run last.**
Possible addition of a 200 Free TT for 12&U
- FORMAT:** **All events are timed finals. Slow to fast standard pre-seed seeding, except for the 1650 which will be seeded fastest to slowest.**
Metropolitan Association scratch rules will be in effect for this meet.
- ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet.
Age on **December 1, 2019** will determine age for the entire meet.
No Time or NT is not acceptable.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** **Entries will be accepted on a first come first serve basis.**
Meet will be run using Hy-Tek's Meet Manager. All entries must be in yards, NTs will not be accepted. All entries must be sent in Team Manager format.

- DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be received by **November 14, 2019.**
2: The final entry deadline for this meet is **November 24, 2019**
3: Metro entries received between September 1 and November 14 and all entries from other LSC's will be entered in the order they were received, as space allows.
An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days of your original email.
- ENTRY FEE:** An entry fee of **\$5** per individual event must accompany the entries.
Make check payable to: **NDAC.**
Payment must be received by **November 29, 2019** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- WARM-UP:** **Assigned warm-up procedures will be in effect.**
- SCRATCHES:** **The scratches for the 1650 are due the day before (Saturday, Nov.30) at noon. We will notify the coaches by 3 pm who is seeded in the first 3 heats. Please make sure we have your cell number.**
All other scratches are due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches and which swimmers will not be participating in the session.

- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** Events will be scored as following:
Open 1650: Ribbons for Places 1-6.
400 IM: Ribbons for places 1-6 for 11&Under, 13-14, 15&Older
500 Free: Ribbons for Places 1-6 for 10&Under, 11-12..

- RULES:** The current USA Swimming Rules and Regulations will apply.
The USA Swimming Code of Conduct is in effect for the duration of the meet.
The overhead start procedure may be used at the discretion of the meet Referee.
- SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement.
- MAAP:** Current USA Swimming rules, including the Minor Athlete Abuse Prevention Policy (MAAPP), will govern this meet.
- WATER DEPTH:** Turn end: The water depth at 1.0 meter from wall is 4 feet and at 5.0 meters it is 4.5 feet
Block end: The water depth at 1.0 meter from wall is 13 feet and at 5.0 meters it is 12 feet
- DISCLAIMER:** DISCLAIMER: Upon acceptance of his/her entries, the participant waives all claims against Bard College and Northern Dutchess Aquatic Club, Metropolitan Swimming Inc., USA Swimming Inc., their agents or representatives for any injury occurring as a result of the meet. "It is understood that USA Swimming, Inc. and Metropolitan Swimming, Inc. shall be free from liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event."
- AUDIO/VISUAL STATEMENT:** Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms or behind the starting blocks.
"Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present."
- DECK CHANGING:** Deck changes are prohibited.
- ADMISSION:** \$5 per session
- MERCHANTS:** Metro Swim Shop
- PARKING:** Parking lot on Annandale Road across from Stevenson Gym. Illegally parked cars will be towed at the owner's expense.

DIRECTIONS: **From points south:** New York State Thruway to Exit 19 (Kingston), take Rte. 209 (changes to Rte. 199 at the Hudson River) over the Rhinecliff Bridge to Rte. 9G North, turn left onto Rte. 9G and drive north 3.5 miles- at the light, turn left onto Annandale Rd.– college is 1 mile north.
From points north: New York State Thruway to Exit 19 and proceed as from points south.
