

ELIGIBILITY: Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

No "Deck Registrations" will be accepted

Age on November 16, 2019 will determine age for the entire meet.

SWIMMERS: special consideration.

The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any

disability prior to the competition.

ENTRIES: All Athletes are limited to enter 3 events per session

Deck entries will not be accepted.

DEADLINE: 1: Metro LSC teams will be given priority on a first come/first served basis. Metro team's entries

must be received by November 1, 2019

2: The final entry deadline for this meet is **November 10, 2019**

3: Metro entries received between November 1, 2019 and November 5, 2019 will be entered first.

Entries from other LSC's will be entered in the order they were received, as space allows.

ENTRY FEE: An entry fee of \$5.00 per individual event must accompany the entries.

Payment must be received by 11/16/19 for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes will be

available for the remaining 10 minutes. Lane assignments will be distributed along with the scratch

sheet each session.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later

than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual

events scratches and which swimmers will not be participating in the session.

In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid COACHES:

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who

do not possess these credentials will be required to leave the deck area.

AWARDS: 12 and Under Only will receive awards, 1st thru 6th place

RULES: The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Prevention

Policy (MAAPP) will apply.

The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee.

SAFETY: All swimmers must wear footwear upon leaving the pool area.

> Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. "Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure

compliance with this requirement"
