COVID-19 Information

- **Masks are required for anyone in attendance, except athletes only while swimming.**
- **Entries will be limited to conform to facility capacity limits.**
- **In-person spectating will not be available for this meet, except for Session #1 if space allows (8 & Unders). Spectators must enter and exit through the “Pool Entrance” and sit in the spectator area near the Start end.**

- FORMAT:** This meet will be Pre-Seeded; No scratches, no changes will be permitted at the table. Scratches from finals will be done via Google form sent to participating coaches after entries are finalized.
- All events on Thursday and Friday are timed finals. All 10 & Under events are timed finals. Open and 11-12 events on Saturday and Sunday are prelims-finals. In 11-12 events, the top 12 athletes will advance to finals (2 heats). In Open freestyle and events 100yds and longer, the fastest 24 athletes will advance to finals (4 heats). In the Open 50yd Backstroke, Breaststroke, and Butterfly, 12 athletes will advance to finals (2 heats). In all Open events, the 1 slowest heat in finals will be open to athletes 14 & Under athletes only.
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. No "Deck Registrations" will be accepted. Age on December 9, 2021 will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.

- NTs (No Times) will not be accepted. Entries will be cut on a first come first serve basis. Athletes may be entered in a maximum of 1 timed finals or prelim session per day. Maximum entries will be as follows:

Session 2 - Open Timed Finals - 2 events
Session 3 - 12 & Under Timed Finals - 2 events
Sessions 4,8 - Open Prelims - 3 events
Sessions 5,9 - 12 & Under Prelims - 3 events
Sessions 6,10 - 9-10 Timed Finals - 3 events
- DEADLINE:** **Entries Must be received by December 2, 2021.**

- ENTRY FEE:** An entry fee of \$7 per timed final event, \$10 per prelim-finals event, and \$10 athlete surcharge must accompany the entries.

Payment must be received by [December 2](#) for email entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact the meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.
- WARM-UP:** Warm-up lanes will be assigned and posted after entries are closed.
- SCRATCHES:** Scratches from finals will be processed by Google form sent to coaches after entries are received..
- COACHES:** Only those coaches who possess current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave.
- AWARDS:** Medals 1st to 3rd and Ribbons 4th to 6th.

- RULES:** The current USA Swimming Rules and Regulations will apply. The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the Meet Referee.
- SAFETY:** Metropolitan Warm-up procedures will be in effect. Marshals will be present and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

- MAAPP POLICY:** All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- WATER DEPTH:** The pool is 12 feet deep at 1m from the start end, and 11 feet and 6 inches deep at 5m from the start end. The pool is 3 feet and 6 inches deep at 1m from the turn end, and 4 feet deep at 5m from the turn end.
- DISCLAIMER:** Upon acceptance of his/her entries, the participant waives all claims against Hauppauge School District, Hauppauge Athletic Association, Metropolitan Swimming Inc., USA Swimming Inc., their agents or representatives for any injury occurring as a result of the meet. It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
- POLICIES:** Deck changes are prohibited. Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- ADMISSION:** Spectators may be allowed only during Session 1, if space allows. Participating teams will be notified if space allows spectators after entries have been processed. \$6 per spectator, limit 1 spectator per athlete.
- MERCHANTS:** Quality food and beverages are available in the Cafeteria during the meet. TYR Swimsuits, Apparel, and Accessories will be available for sale.
- PARKING:** Parking is free. Ample space is available in the school parking lot.
- DIRECTIONS:** LIE – Exit 57 (Rt. 454 Vets Highway) travel north towards Commack. Make a right turn onto Lincoln Blvd. and a left into the parking lot North of the High School.
